#### I. Confirmation of minutes of meeting

(LC Paper No. CB(1) 617/01-02)

The minutes of the first Subcommittee meeting held on 8 December 2001 were confirmed.

#### II. Meeting with the Administration

2. The Subcommittee deliberated (Index of proceedings attached at **Appendix**).

#### Matters arising from the first meeting

Commencement date of the Amendment Regulation

3. On the Administration's proposal of appointing 10 January 2002 (Thursday) as the day on which the Dutiable Commodities (Amendment) Regulation 2001 (the Amendment Regulation) should come into operation, Assistant Legal Adviser 1 drew members' attention that in accordance with section 34(2) of the Interpretation and General Clauses Ordinance (Cap. 1), if a resolution was passed by the Legislative Council (LegCo) on 9 January 2002 (the expiry date of the extended scrutiny period) to amend the Amendment Regulation, the Amendment Regulation should be deemed to be amended from the date of publication in the Gazette of such resolution, which normally was the following Friday, i.e. 11 January 2002. In response to members' concern about the possible one-day time gap between the commencement date of the Amendment Regulation and the effective date of the amendment resolution, Principal Assistant Secretary for Commerce and Industry confirmed that arrangement had been made for the amendment resolution to be published in the Gazette Extraordinary on 10 January 2002 (Thursday).

#### Regulation 22 and new Regulation 106

4. Referring to the marked-up copy of Regulation 22 and the new Regulation 106 of the Dutiable Commodities Regulations (Cap. 109 sub. leg.) tabled by the Assistant Legal Adviser at the meeting, members suggested and the Administration agreed that the following amendments be incorporated into the resolution to be moved by the Secretary for Commerce and Industry at the Council meeting on 9 January 2002 to amend the Amendment Regulation:

#### Regulation 22

(a) Subregulations (6) and (7) should be combined, and the drafting should be amended to reflect the Administration's policy intent that the Commissioner of Customs and Excise (the Commissioner) would only exercise his power to offer an additional option for traders to submit applications for dutiable commodity permits (DCPs) in paper form under very exceptional circumstances where it was not practicable for an

application to be submitted solely in electronic form, e.g. in case of system failure, or there was a need to allow the Administration to declare a new type of dutiable commodity without having to enhance the computer system in advance, thus maintaining confidentiality for the purpose of revenue protection.

(b) To avoid delay and minimize the disruption to be caused to users under the very exceptional circumstances mentioned in item (a) above, Regulation 22 should be amended to enable the specification made by the Commissioner to take effect before the notice of such specification was published in the Gazette, e.g. to provide that the notice be published in the Gazette within 14 days from the date of specification.

#### New Regulation 106

(c) To provide certainty to all relevant parties, the end date of the proposed six-month transitional period should be specified in the new Regulation 106. To provide flexibility to the Administration, it would be provided in the new Regulation 106 that the Commissioner might amend the end date by notice published in the Gazette before the end date. As the Amendment Regulation was expected to come into operation on 10 January 2002, the end date of the six-month transitional period should be 10 July 2002, the day on which the last LegCo meeting for the 2001-2002 session was scheduled to commence. In the light of previous experience that the last LegCo meeting might last for a few days, the end date might be specified as 19 July 2002 (Friday) to allow time for gazettal of any resolution passed at the meeting to amend the subsidiary legislation.

(*Post-meeting note:* The marked-up copy of Regulation 22 and the new Regulation 106 of the Dutiable Commodities Regulations (Cap. 109 sub. leg.) tabled at the meeting was issued to members vide LC Paper No. CB(1)669/01-02 on 21 December 2001.)

#### Clause-by-clause examination of the three items of subsidiary legislation

- 5. The Subcommittee examined the Amendment Regulation clause by clause. Members proposed no other amendments except those mentioned in paragraph 4 above.
- 6. The Subcommittee examined the Dutiable Commodities (Amendment) Ordinance 2001 (19 of 2001) (Commencement) Notice 2001 and the Dutiable Commodities (Amendment) Regulation 2001 (L.N. 248 of 2001) (Commencement) Notice 2001. Members proposed no amendments.

#### Next step

7. The Subcommittee and the Administration agreed to proceed according to the following timetable:

Upon the Assistant Legal Adviser's confirmation the that proposed amendments contained in the draft resolution were legally in order, the Clerk to Subcommittee to forward the draft resolution to members for consideration By 12:00 noon, Deadline for members to comment on 31 December 2001 (Monday) the proposed amendments. By 2 January 2002 (Wednesday) Deadline for the Secretary for Commerce and Industry to give notice of motion to amend the Amendment Regulation at the LegCo meeting on 9 January 2002. 2 January 2002 (Wednesday) The Subcommittee to submit a written report to the House Committee for its meeting on 4 January 2002 (Friday).

(*Post-meeting note:* The draft resolution to be moved by the Secretary for the Commerce and Industry was circulated to members on 27 December 2001 vide LC Paper No. CB(1) 676/01-02. The Administration agreed to the Assistant Legal Adviser's suggestion that the end date specified in Regulation 106(2)(a) and (3) was **20 July 2002 (Saturday)** to provide for the possibility of a resolution of LegCo published in the Gazette on 19 July 2002 (Friday) to amend the notice.)
