- 3. The Subcommittee deliberated (Index of proceedings attached at **Annex**).
- 4. The Subcommittee was in support of the policy objective of the Revenue (Variation and Reduction of Fees and Charges) Order 2002 ("the Order"). During the deliberation, members raised concern on the following matters:
 - (a) the propriety of using section 39A of the Public Finance Ordinance (PFO) to effect the proposed waiver of business registration fees and reduction of water and sewage charges and trade effluent surcharges;
 - (b) the administrative arrangements and resource implications for implementation of the proposed waiver and reduction of fees and charges as mentioned in (a);
 - (c) the scope of power conferred on the Chief Executive (CE) under section 39A(a) of PFO and the availability of adequate checks and balances;
 - (d) the possibility that future variation in fees and charges effected through an order made under section 39A(a) of PFO might contravene the statutory provisions of relevant charging regimes;
 - (e) the use of section 39A(b) of PFO to effect refund of certain business registration fees and the refund arrangements;
 - (f) whether sections 4(3)(a) and 5(3)(a) of the Order in relation to water charges for domestic purposes and flushing purposes would in effect vary the method of billing specified under the Waterworks Regulation; and
 - (g) the propriety of arranging the Order to commence operation before the completion of the scrutiny of the Order by the Legislative Council.
- 5. The Administration undertook to review members' concern on item (d) in any future proposal involving the use of section 39A(a) of PFO.
- 6. Since the Subcommittee had completed the scrutiny of the Order, members agreed that a report on the deliberations of the Subcommittee would be made to the House Committee at its meeting on 12 April 2002. The Subcommittee noted that as agreed at the House Committee meeting on 22 March 2002, the Chairman of the House Committee would move a motion at the Council meeting on 10 April 2002 to extend the scrutiny period of the Order to the Council meeting on 17 April 2002.
