I. The meeting

The Subcommittee deliberated (index of proceedings at **Annex A**) on -

- (a) the Administration's response on the election expenses incurred by candidates of the first term Chief Executive (CE) election;
- (b) the Electoral Procedure (Chief Executive Election) Regulation (L.N. 233 of 2001); and
- (c) the Chief Executive Election (Election Petition) Rules (L.N. 241 of 2001).
- 2. To facilitate the work of the Subcommittee, the Administration was requested to -

L.N. 233 of 2001

(a) provide the draft amendments for a declaration of secrecy by any person other than a Returning Officer in the presence of a Justice of the Peace;

L.N. 241 of 2001

Sections 3 and 4

- (b) explain whether sections 3 and 4 as presently drafted amounted to amending the practice and procedure of the High Court and the High Court Fees Rules and how these sections would operate by giving some examples;
- (c) consider repealing the words "as nearly as circumstances permit" in section 3 and the words ", subject to all necessary modifications," in section 4;

Section 8

- (d) explain whether the requirement for a petitioner to apply to a judge for fixing the date of a trial within two days after the filing of the election petition in sub section (1)(b) was reasonable;
- (e) advise whether a mechanism was in place to ensure that any election petition lodged would be disposed of before 1 July 2002 (in the case of the coming election);

Section 15

- (f) consider a member's view that the petition in section 15(1)(b) and (c) should not be regarded as having been withdrawn and to explain whether there were any other avenues for the petitioner to further pursue the matter if the election petition was regarded as withdrawn;
- (g) consider deleting the words "the proceedings for" at the beginning of section 15(2);
- (h) consider whether any person other than the solicitor acting for the petitioner or the respondent should be responsible for filing a notice of the death of the petitioner, and to consider amending the provisions having regard to other similar statutes; and

Section 19

- (i) consider rewording the word "defrayed" in section 19(1).
- 3. The Subcommittee also requested Assistant Legal Adviser 4 to provide a legal advice on the issue relating to the circumstances in which petition was regarded as withdrawn (section 15).

II. Any other business

- 4. Having completed its scrutiny of L.N. 232 and 233 of 2001, the Subcommittee agreed that a report be made to the House Committee at its meeting on 30 November 2001.
- 5. The Subcommittee agreed to hold the next meeting on 3 December 2001 at 8:30 am to discuss outstanding issues and continue the scrutiny of L.N. 241 of 2001.
- 6. There being no other business, the meeting ended at 10:15 am.
