The Subcommittee deliberated (Index of proceedings attached at Annex).

2. As requested by the Subcommittee, the Administration undertook to consider the following and provide the Subcommittee with a written response -

(a) Section 7 - Classification

whether the word "training" in section 7 could denote the nature of the activities in a Rehabilitation Centre vis-a-vis those in a Training Centre;

(b) Section 12 - Board to make recommendations for offender's promotion and discharge

Section 13 - Functions of Board

- (i) whether the repetition of the functions of the Board of Review in sections 12 and 13 was necessary and if so how it could be avoided;
- (ii) whether there was a more suitable Chinese name for the Board of Review;
- (c) Section 14 Supervision Order
 - (i) whether section 14 should also provide that if a supervision order was varied after the release of an offender from a rehabilitation centre, the revised supervision order should also be read and explained to the offender;
 - (ii) whether a supervision order should be read and explained to an offender in the presence of his parent(s) or guardian;
 - (iii) whether the signature of an offender should be required by way of acknowledgement in a supervision order;
- (d) Section 16 Procedures relating to drug tests

whether a copy of the acknowledgement of the notice to supply urine specimen for testing (Form 8 of Schedule 3) should be provided to the offender;

(e) Section 17 - Leave of absence

whether the period of leave of absence (not exceeding five consecutive days at any one time) should be extended;

(f) Section 20 - Report

whether the drafting of section 20 should be amended, in particular the words "dealt with", to the effect that the duties of a Superintendent in handling reports of disciplinary offences prescribed under section 19 would be clearly defined; and

(g) Schedule 1 of the Regulation - Conditions of a supervision order

whether the conditions of a supervision order should be made more extensive so that an aftercare officer would be able to exercise more supervision on an offender if the situation warranted.

- 3. The Administration was also requested to provide information on how the Correctional Services Department (CSD) had helped young offenders with very complicated family background to reintegrate into society after release from a CSD institution.
- 4. As requested by the Administration, the Chairman agreed that the Administration's written response to the above issues could be made in English first due to time constraint, with the Chinese version to be provided as soon as possible thereafter. However, any proposed amendments should be submitted in bilingual form.
- 5. The Subcommittee agreed that the scrutiny period be extended to 14 November 2001 and that a further meeting should be held on 2 November 2001 immediately after the House Committee meeting scheduled for 2:30 pm on that date to consider the Administration's response and discuss any outstanding matters.
- 6. There being no other business, the meeting ended at 1:10 pm.
