The Subcommittee deliberated (Index of proceedings attached at **Annex**).

2. Members questioned about the arrangements for permitting inmates of Correctional Services Department (CSD) institutions to participate in activities in places outside Hong Kong and requested the Administration to provide information on such arrangements for their reference.

<u>Section 11 – Religious services and instruction</u>

3. Ms Cyd HO expressed grave reservation in the Administration's response regarding section 11. The Chairman asked the Clerk to check with Ms HO after the meeting on whether she would move any amendment to the section and, if so, the Subcommittee should as far as possible discuss the proposed amendment.

<u>Section 14 – Supervision order</u>

4. As requested by the Subcommittee, the Administration would move a motion to amend section 14 to put the administrative arrangement for serving a supervision order, or a varied supervision order, on a statutory footing. The Administration undertook to review the drafting of its proposed amendment to more adequately reflect the legislative intent in the light of the comments made by the Assistant Legal Adviser.

<u>Schedule 1 – Conditions of a supervision order</u>

- 5. The Administration agreed to reconsider the Subcommittee's view that in order to enable the Commissioner of Correctional Services to impose more stringent supervision conditions in warranted cases, the scope of paragraphs (j) and (k) in Schedule 1 should be extended to cover any other offence of which an offender had previously been convicted. The Chairman indicated that he or the Subcommittee would move an amendment to that effect if the Administration was not prepared to do so. He requested the Assistant Legal Adviser to prepare a draft of his proposed amendments to Schedule 1 for members' consideration.
- 6. The Subcommittee agreed to hold a further meeting on 5 November 2001 at 9:30 am to consider the Administration's response and discuss any outstanding matters.
- 7. There being no other business, the meeting ended at 6:05 pm.
