*Section 11 – Religious services and instruction* 

- 2. The Administration accepted members' suggestion and agreed to expand the section to codify the administrative arrangement to provide, as appropriate, religious instruction to inmates who did not belong to a religious denomination.
- 3. As requested by Ms Cyd HO, the Administration also undertook to provide information on the frequency of visits made by chaplains of the various denominations to CSD institutions.

(*Post-meeting note*: CSD advised that visits by prison chaplains and/or approved personnel of various religious denominations are frequent and, in general, each institution is visited by such people once a week.)

Section 14 - Supervision order

4. The Subcommittee agreed to the Administration's revised proposed amendment tabled at the meeting.

#### Schedule 1 – Conditions of a supervision order

- 5. As suggested by the Subcommittee, the Administration undertook to further consider whether it would move amendments to both paragraphs (j) and (k) of Schedule 1 taking into account the draft resolution proposed by the Chairman which was tabled at the meeting. The Chairman indicated that if the Administration decided not to do so, he would move the amendments in his name.
- 6. The Subcommittee requested the Administration to provide the Secretariat with the proposed resolution(s) before close of play on 6 November 2001 for onward transmission to members.
- 7. There being no other business, the meeting ended at 11:20 am.
