II. Meeting with the Administration

- 2. The Subcommittee deliberated (index of proceedings attached at **Annex**).
- 3. As requested by the Subcommittee, the Administration undertook to provide the following information to facilitate the work of the Subcommittee -
 - (a) whether there were provisions in the International Covenant on Civil and Political Rights and other international treaties as applied to Hong Kong providing that surrender might be refused if the requested Party considered that the person sought would not receive a fair trial in the territory of the requesting Party;
 - (b) what the jurisprudence on fair trial in the context of extradition was;
 - (c) whether there was any mechanism to enable the requested Party to take necessary action if it found that a person, after having been surrendered, could not receive a fair trial in the territory of the requesting Party;
 - (d) whether to surrender a person for serving in the territory of the requesting Party an imprisonment sentence upon his conviction in absentia would be in conformity with international obligations in connection with the right to fair trial;
 - (e) relevant provisions in the Fugitive Offenders Ordinance (Cap. 503) concerning the basis on which a person could resist extradition;

<u>Action</u>

- (f) a table setting out the "three-stage" procedure regarding extradition, i.e. the committal proceedings, making representation to the Chief Executive and application for habeas corpus, and the matters/grounds that would be considered in each of the stages; and
- (g) case law(s) concerning offences of a political character.
- 4. The Subcommittee agreed that the Chairman of the Subcommittee would move a motion at the Council meeting on 14 November 2001 to extend the scrutiny period of the Fugitive Offenders (Sri Lanka) Order and Fugitive Offenders (Portugal) Order to the Council meeting on 21 November 2001.
- 5. The Subcommittee also agreed to hold the next meeting on 15 November 2001 at 9:00 am.
- 6. There being no other business, the meeting ended at 10:13 am.
