Fugitive Offenders (Sri Lanka) Order

I refer to the several telephone conversations with your Miss Angelina Kwan last week. During those telephone conversations, I informed Miss Kwan of my concern in respect of the discrepancies between the Chinese version of Article 2 of the Fugitive Offenders (Sri Lanka) Order and the Chinese version of the Schedule to the Fugitive Offenders Ordinance (Cap. 503) (the Ordinance) and requested a written response from the Administration. During the telephone conversation this morning, Miss Kwan asked me to put my queries in writing before a written response would be made. That I now do.

I set out in the attached Annex the more significant discrepancies in the description of the same offences between the Chinese version of the Order and the Chinese version of the Schedule to the Ordinance for your consideration. I would be grateful if you could clarify whether Article 2 in the Agreement made between the Government and the government of Sri Lanka needs to follow the wording of the Schedule when describing the same offences. If the answer is in the negative, please give the reasons for your opinion. If the answer is in the affirmative, please let me know what action the Administration would propose to remedy the fiat accompli.
