#### I. Meeting with the deputations

2. The Subcommittee received views from Professor Ken SHORTRIDGE, Chair Professor, Department of Microbiology, The University of Hong Kong and representatives of seven deputations and individuals from the quail trade on the Regulations.

#### **II.** Meeting with the Administration

- 3. In response to Mrs Selina CHOW and Ms Cyd HO, the Chairman advised that as the Subcommittee had taken a decision at the last meeting not to pursue the proposal of repealing the Regulations, it would not be appropriate for the Subcommittee to re-open discussion of the same proposal and vote on it again.
- 4. The Subcommittee requested the Administration to provide a response to the following issues raised -
  - (a) ways/arrangements to enable the quail trade to continue under the segregation policy;
  - (b) whether the Administration had made reference to the practices in other places (including the Mainland) where live quails were sold with other poultry in markets;
  - (c) the number of animal trader licences issued by the Agriculture, Fisheries and Conservation Department;
  - (d) the Administration to consider granting ex-gratia allowance payment to quail farmers expeditiously irrespective of whether the Regulations would come into effect; and
  - (e) the Administration to consider repealing the three Regulations, pending a comprehensive review on the policy on live poultry.
- 5. In respect of concerns raised by deputations at the meeting of 13 November 2001, the Administration was requested to provide any other information in addition to the response made at the meeting.

- The Subcommittee agreed to tentatively schedule the next meeting for 21 6. November 2001 at 10:45 am.
- There being no other business, the meeting ended at 11:05 am. 7.
