- 5. Members generally expressed the view that the application procedures for a new AIO in case of change of income source should be made more user-friendly. Forms and more guidance should be provided to help those who had to comply with the procedures to do so without the need for legal representation. The Administration undertook to liaise with the Judiciary and consider members' views in this regard.
- 6. The Subcommittee agreed that the Chairman should seek to extend the scrutiny period to 16 January 2002 and that the next meeting should be held on 28 December 2001 at 2:30 pm to consider the Administration's response.
- 7. There being no other business, the meeting ended at 5:35 pm.
