I. Election of Chairman and Deputy Chairman for the 2001-2002 session

Election of Chairman

Mr Fred LI invited nominations for the chairmanship of the Panel for the 2001-2002 session, in accordance with the election procedure set out in Appendix IV of the House Rules.

- 2. <u>Mr Tommy CHEUNG</u> nominated Mr Fred LI. Miss CHOY So-yuk seconded the nomination. Mr LI accepted the nomination.
- 3. Mr Tommy CHEUNG took over from Mr Fred LI to preside over the election of the Chairman of the Panel. As there was no other nomination, <u>Mr Tommy CHEUNG</u> declared Mr LI elected as Chairman of the Panel.

Election of Deputy Chairman

- 4. Mr Fred LI took the chair and presided over the election of the Deputy Chairman of the Panel for the 2001-2002 session.

Items (a) and (c) will be placed on the list of outstanding issues to be considered by the Panel.)
