3. Risk assessment studies on food and food surveillance

Before the Avian Flu Incident in May 2001, the total number of live poultry stalls/shops was 886. At present, there are 858 live poultry stalls/shops. We do not have any statistics on the total number of persons engaged in the live poultry retail trade. However, we understand that a live poultry stall/shop usually employs 2 to 3 workers.

4. Alignment of fees and charges under the purview of FEHD

(a) Current fees and charges

A table showing the level of charges of the 94 fee items under the purview of FEHD is at Annex I.

(b) Cost computation formulae

It is general practice that in computing the full costs of a service provided by the Government, we take into account the direct and indirect expenditure attributable to the provision of the service in accordance with generally accepted accounting and costing principles and conventions, including –

- Expenditure that is fully attributable and chargeable to the provision of the service,
 e.g. direct material and staff costs;
- Expenditure which cannot fully attributed or charged to the provision of the service but can be apportioned on a reasonable basis, e.g. electricity and rent;
- Capital expenditure which has been incurred in full or in part for the purposes of providing the service and is accordingly written off over a period of time by way of depreciation, e.g. computer hardware;
- Costs which are related to the provision of the service but do not involve cashflow expenditure, e.g. notional accommodation costs for a service provided in government-owned premises;

- Cost of work performed by other government entities which is directly related to the provision of the service, e.g. services provided by Fire Services and Buildings Departments in assisting Home Affairs Department in the issue of clubhouse licences; and
- A share of the administrative expenses of the department providing the service and a share of Central Departments' costs note, which are collectively know as administrative overheads.

Note

There are a total of 12 Central Departments providing support services for other departments. The full costs of the centralized services, e.g. audit, legal, accounting, translation, etc. are apportioned to functional departments as Central Administrative Overheads in accordance with the amount of services received by them.

(c) Feasibility of simplifying the current licensing framework and the various types of fees and charges

The feasibility of simplifying the current licensing framework and the various types of fees and charges is being considered. We shall revert to LegCo with full details in 2002.

(d) Transfer of services to other departments

Members had suggested that FEHD should consider the transfer of certain types of services, such as private swimming pools, to the Leisure and Cultural Services Department (LCSD). In fact, to rationalize the existing arrangement under which public swimming pools are under the supervision of LCSD while private swimming pools are under the FEHD licensing regime, we are in dialogue with LCSD for a transfer of the control to LCSD. Similarly, FEHD is in dialogue with the Home Affairs Bureau (HAB) on the transfer of the licensing responsibility over places of public entertainment back to HAB in the appropriate future.
