## Legislative Council Panel on Home Affairs 11 January 2002

## **Provision of Community Facilities**

### **Purpose**

This paper provides an overview of the existing and planned provision of sports and recreational facilities, libraries, civic centres and community halls in Hong Kong.

### **Background**

2. Members expressed concern about the provision of sports and recreational facilities, libraries, civic centres and community halls in some districts, particularly in the new towns. Related issues have also been raised at LegCo Members' meetings with members of the Tai Po District Council, Eastern District Council and Islands District Council. Requests have been made to provide a new civic centre cum district library complex in Tai Po, and various community facilities in Shaukeiwan and Tung Chung.

### **Existing Provision**

Sports and Recreational Facilities

3. The Leisure and Cultural Services Department (LCSD) manages a variety of sports and recreation facilities. Apart from parks and playgrounds, major sports and recreation facilities include 82 indoor games halls/sports centres, 36 swimming pool complexes and 24 sports grounds. A list of these facilities is given in <u>Appendix I</u>.

#### Libraries and Civic Centres

4. LCSD also operates a network of 69 public libraries, comprising one central library, 5 major libraries, 26 district libraries, 29 small libraries and 8 mobile libraries. In addition, LCSD manages 15 civic centres including 4 territory-wide venues and 11 regional/district venues.

#### Community Halls

5. Community halls (CHs) provide venues for a range of community activities including meetings of local organizations; civic education activities; training courses; celebrations and recreational and cultural activities at the district level. They also provide temporary shelters for people in need during natural disasters, emergency situations and inclement weather. CHs are normally centrally located and easily

accessible to the population they intend to serve. A standard CH includes a multipurpose hall with a stage, a conference room, a management office, dressing rooms and storerooms. At present, there are 76 CHs under the management of the Home Affairs Department (HAD).

#### **Planned Provision**

#### LCSD Facilities

- 6. LCSD facilities are planned having regard to :
  - the speed of population in-take, particularly in new towns such as Tin Shui Wai, Tseung Kwan O, Tung Chung and Ma On Shan
  - local demand for new and existing facilities including usage rates at other similar venues in the Districts concerned
  - the general provision and distribution of facilities in individual districts
  - the criteria/recommended provision set out in the Hong Kong Planning Standards and Guidelines (HKPSG) (such standards and guidelines are by no means mandatory and should be applied with flexibility)
- 7. At present, there are 12 capital works projects under construction (<u>Appendix II</u>); 10 capital works projects with funding earmarked in Category B of the Public Works Programme (<u>Appendix III</u>); and 64 capital works projects under the Accelerated Programme<sup>1</sup> (<u>Appendix IV</u>) for construction to start within the next five-year from 2002-03 to 2006-07.
- 8. Upon completion of the above capital works projects, many new facilities will be made available to meet community needs in the high population in-take areas and the new towns. These include 16 indoor recreation/leisure centres, 11 public libraries, 4 swimming pool/complexes, 33 open space developments, 20 parks/playgrounds, etc. In addition, the Government is planning to develop the West Kowloon Reclamation into a cultural and entertainment district, which will include a performing arts venue for staging world-class events.
- 9. LCSD is committed to expediting project planning and has in fact drawn up an accelerated implementation plan for the 64 capital works projects in the Accelerated Programme. LCSD will closely monitor progress of the capital works projects and will keep under view ways to compress the planning lead time so that new facilities would be provided early for use by the public.
- 10. LCSD is aware of the requests from a number of District Councils for the provision of new civic centres. The Home Affairs Bureau (HAB) and LCSD are conducting a consultancy study on the provision of regional/district cultural and performance facilities in Hong Kong. The consultancy study would take into account,

as a whole, the current provision of similar facilities, major facilities under planning, views of relevant committees and organizations including the Culture and Heritage Commission, District Councils, community groups and arts groups, residents and visitors. The study is expected to be completed by the first half of 2002 and there will be further consultation when findings of the study are available.

## Community Halls

- 11. The general principles governing the provision of CHs are set out in the latest HKPSG, according to which CHs should be provided on a "need basis" on individual merits, taking into account the following factors
  - population size
  - area characteristics and community aspirations
  - location of the area concerned
  - availability of existing CHs or similar facilities nearby
  - the usage rates of nearby CHs
  - accessibility of nearby CHs to the subject area
  - availability of alternative accommodations for community activities and their ease of access.

Under the HKPSG, CHs will usually form part of an integrated development, instead of being stand-alone developments. In addition, it is no longer necessary for a CH to be colocated with a welfare block (as in the case of existing "community centres"), although welfare services and facilities would often be one of the joint users in an integrated development. In developing a joint-user complex, HAD needs to identify suitable joint users and to achieve a plot ratio to the satisfaction of the Government Property Agency.

- 12. At present, there are 12 CH projects under construction (<u>Appendix V</u>), one of which is located at Aldrich Bay. There are four CH projects (located in Tuen Mun, Stanely and Kennedy Town) which will be submitted to the Legislative Council for funding approval shortly. A number of CH facilities are also under planning including three in Siu Sai Wan, Sai Wan Ho and Tung Chung.
- 13. As the bureau overseeing both community building and cultural and recreational policies, HAB is considering adopting a more coordinated and integrated approach to the provision of district-based facilities serving sports, recreation and community building purposes to ensure that they meet the needs of the community and are provided in a cost-effective manner. In this connection, we are examining the desirability and feasibility of two proposed arrangements for providing CHs and indoor games halls (IGHs). First, we will consider providing a new type of multi-purpose venue to serve both community building and sports and recreational purposes, where there is a need to provide both types of facilities in a particular area. Second, we will consider whether some existing IGHs, when suitably equipped, can be used to serve CH purposes to cater for local demand. We believe that an integrated and coordinated approach would enable the best possible use of the sites and resources available and ensure that the facilities provided in the venue meet the needs of the local community. Pilot schemes are being carried out to test the practicability of these two proposed arrangements.
