Gambling Ordinance (Chapter 148)

GAMBLING (AMENDMENT) REGULATION 2002

INTRODUCTION

At the meeting of the Executive Council on 4 June 2002, the Council ADVISED and the Chief Executive ORDERED that the Gambling (Amendment) Regulation 2002 at **Annex A** should be made under section 28 of the Gambling Ordinance (Cap. 148), to revise the prescribed conditions of the Lottery, Trade Promotion Competition (TPC) and Mahjong/Tin Kau Licences.

BACKGROUND AND ARGUMENT

General Background

- 2. Under section 22 of the Gambling Ordinance, the Commissioner for Television and Entertainment Licensing (CTEL) may by licence authorize lotteries, TPCs¹ and the operation of mahjong/tin kau parlours. The licence forms are prescribed in the Gambling Regulations (Cap. 148 sub. leg. A). The forms contain the prescribed conditions to which the licences are subject. These licensing conditions aim at regulating and controlling the conduct of these activities in accordance with our gambling policy, i.e. to restrict gambling opportunities to a limited number of authorized outlets only. They are intended as means to prevent fraudulent practices arising from these gaming activities and hence safeguard public interests.
- 3. Most of the licensing conditions dated back to the late 1970s. In recent years, there has been feedback from various parties concerned that some of the conditions have become outdated and are too restrictive to the trades in the prevailing business environment, while some should be suitably tightened for the purpose of effective supervision in the light

of changing circumstances. In view of these concerns, we have reviewed the conditions and identified some areas for improvement. The proposals seek to ensure that we have in place a licensing regime which maintains effective control over the licensed activities in a way that is not unduly restrictive to the affected sectors. The proposals entail amendments to the Gambling Regulations.

The Proposals

(A) Proposals relating to Lottery Licence

(a) To extend the time limit for publishing draw results and to reduce the required number of newspapers for this purpose

4. Licence Condition 5 requires the draw results of the lottery to be published in two English and two Chinese newspapers within seven days from the date of the draw. Lottery organizers consider the seven-day limit too tight and the cost of publishing the results in two English and two Chinese newspapers rather high, especially for smaller scale events. To alleviate the burden on the organizers without compromising on the need to ensure transparency and accountability of lottery results, we propose to amend the condition by extending the limit to ten days, and requiring the results to be published in one English and one Chinese newspaper only.

(b) To require submission of a copy of a report made by a "practice unit" stating that the accounting statement is properly prepared

- 5. Licence Condition 6 requires the licensee to prepare a statement of all moneys collected from the sale of lottery tickets and every disbursement made from the moneys so collected, and forward to CTEL a copy of the statement within 28 days from the date of the draw.
- 6. In response to rising community concerns over whether the increasing number of fund-raising lotteries are effectively monitored and their proceeds properly accounted for, we intend to strengthen and rationalize control over such activities through tightening the licensing conditions for lotteries. Specifically, we propose to revise the above condition by adding a requirement that the licensee has to submit a copy

of a report made by a practice unit² as defined under the Professional Accountants Ordinance (Cap. 50) stating that the statement is properly prepared from the books and records of the licensee and nothing indicates that the statement does not accurately reflect all the moneys collected and all the disbursements made therefrom. The copy of the statement and the report will be made available for public inspection. To allow sufficient time for preparation of the statement and the report, the deadline for submissions to CTEL should be revised to 90 days from the date of the draw. This proposed new requirement and the 90-day limit are in line with the Social Welfare Department's requirement in respect of charitable fund-raising activities in public places governed by Public Subscription Permits.

(B) Proposals relating to TPC Licence

(a) To quote licence number in advertisements

7. Licence Condition 3 prohibits advertising in respect of a TPC from referring to CTEL's approval but allow such advertising to state the licence number. The rationale for this is obscure and cannot be traced. We propose to amend the condition by removing the prohibition and simply requiring the licensee to quote the licence number in such advertising so that the public would know that the competition has obtained the necessary approval from the Government.

(b) To extend the time limit for publishing draw results and to reduce the required number of newspapers for this purpose

8. Similar to the Lottery Licence, TPC Licence Condition 4 requires the results of the competition to be published in two English and two Chinese newspapers within seven days from the date of the draw. For the same reasons underlying the proposed change to the same condition for Lottery Licence (see paragraph 4 above), we propose to amend the condition by extending the time limit for publishing results to ten days and requiring the results to be published in one English and one

Chinese newspaper only.

(C) Proposal relating to Mahjong/Tin Kau Licence - to relax the requirement on submission of monthly statement of account

9. Licence Condition 7 requires the licensee to forward to CTEL a copy of statement of account on the details of the games played at the end of every calendar month. This is considered too restrictive by the trade. Operational experience reveals that the monthly submission of the licensees' accounting statements is not essential to the effective supervision of mahjong/tin kau parlours. To reduce the administrative burden on licensees without compromising on the need for effective control over such gambling establishments, we propose to amend this condition to the effect that if CTEL requests a copy of the statement during the next seven years, the licensee shall forward such a copy to CTEL within seven days after the request. In any event, under section 51C of the Inland Revenue Ordinance (Cap. 112), a business operator has a duty to retain business records for a period of not less than seven years.

THE REGULATION

- 10. The main provisions of the proposed Regulation are as follows:
 - (a) section 3(a) amends Condition 5, and repeals and replaces Condition 6, of Form 1A of the Second Schedule (i.e. the prescribed form for Lottery Licence);
 - (b) section 3(b) amends Conditions 3 and 4 of Form 4A of the Second Schedule (i.e. the prescribed form for TPC Licence); and
 - (c) section 3(c) repeals and replaces Condition 7 of Form 5A of the Second Schedule (i.e. the prescribed form for Mahjong/Tin Kau Licence). It also repeals and replaces Note 3 of the Form because of the proposed Condition 7.

The Second Schedule to the existing Gambling Regulations is at **Annex B**.

PUBLIC CONSULTATION

11. We consulted the Legislative Council Panel on Home Affairs on the proposed legislative amendments on 12 March 2002. Members indicated no objection to the proposals.

BASIC LAW IMPLICATIONS

12. The Department of Justice advises that the proposed Regulation is consistent with the Basic Law.

HUMAN RIGHTS IMPLICATIONS

13. The Department of Justice advises that the proposed Regulation has no human rights implications.

BINDING EFFECT

14. The proposed Regulation will not affect the current binding effect of the Gambling Ordinance.

FINANCIAL AND STAFFING IMPLICATIONS

15. The proposal to relax the requirement for Mahjong/Tin Kau licensees to submit monthly account statements will marginally reduce the administrative workload of the Television and Entertainment Licensing Authority. The other proposals have no financial or staffing implications.

ECONOMIC IMPLICATIONS

16. The proposed requirement for Lottery licensees to have their accounting statements reviewed by practice units as defined under the Professional Accountants Ordinance will increase demand for such professional services. The proposed reduction in the number of newspapers required for publishing TPC draw results will help reduce operating costs relating to trade promotion activities. The benefits generated for the trade concerned would however be insignificant. The

other proposals do not have major economic implications.

SUSTAINABILITY IMPLICATIONS

17. The proposal has no sustainability implications.

GAMBLING (AMENDMENT) REGULATION 2002

(Made by the Chief Executive in Council under section 28 of the Gambling Ordinance (Cap. 148))

1. Commencement

This Regulation shall come into operation on a day to be appointed by the Secretary for Home Affairs by notice published in the Gazette.

2. First Schedule amended

The First Schedule to the Gambling Regulations (Cap. 148 sub. leg.) is amended, in Form 1, by repealing "at lottery" and substituting "a lottery".

3. Second Schedule amended

The Second Schedule is amended –

- (a) in Form 1A
 - (i) in Condition 3, by repealing "重覆" and substituting "重複";
 - (ii) in Condition 5
 - (A) by repealing "7" and substituting "10";
 - (B) by repealing "2" where it twice appears and substituting "one";

inspection in such manner, and for such period, as the Commissioner thinks fit.";

(b) in Form 4A -

- (i) in Condition 3, by repealing "not refer to the Commissioner's approval of the competition but may state the number of this licence" and substituting "refer to this licence by stating its number";
- (ii) in Condition 4
 - (A) by repealing "7" and substituting "10";
 - (B) by repealing "2" where it twice appears and substituting "one";
 - (C) by repealing "newspapers" and substituting "newspaper";

(c) in Form 5A –

- (i) by repealing Condition 7 and substituting
 - "7. The licensee shall keep a statement of account in the attached form for every calendar month in respect of each day's play including the number of games played, winnings and losses incurred by employees and commission retained.

 If during the period of 7 years after the last day of the month to which the

statement relates, the Commissioner for Television and Entertainment Licensing makes a written request for a copy of the statement, the licensee shall forward such copy to the Commissioner within 7 days after the date on which the request is made.";

- (ii) by repealing Note 3 and substituting
 - "3. If during the period of 7 years referred to in condition 7, the Commissioner for Television and Entertainment Licensing makes a written request for a copy of the statement of account referred to in that condition, such copy must be forwarded to the Commissioner within 7 days after the date on which the request is made.".
