2. The English version of the submission from the Hong Kong Bar Association (the Bar) was tabled at the meeting.

(Post-meeting note: The English version of the submission from the Bar was circulated to members vide LC Paper No. CB(1)1756/02-03 on 23 May 2003.)

3. The Bills Committee deliberated (Index of proceedings attached at **Appendix**).

Way forward

- 4. Mr Andrew WONG considered that before the Bills Committee examined the details of the proposed land title registration system (LTRS), it should first be ascertained whether members accepted the proposed change from the current deeds registration system to LTRS. If members did not accept the proposed change, there was no need to further scrutinize the Bill.
- 5. Whist appreciating Mr Andrew WONG's concern, the Chairman pointed out that the Bills Committee needed to examine the key features of the proposed LTRS before members could decide whether the proposed system should be supported. Other members shared her view. At the suggestion of the Chairman, the Bills Committee decided to continue discussion of the policy issues and review the situation in June before deciding on the way forward.
- 6. The Land Registrar advised that the Administration would try to address the concerns raised by the Bills Committee and the relevant parties, including the legal practitioners. In this connection, the Administration would continue to work closely with The Law Society of Hong Kong (Law Soc).

Follow-up actions to be taken by the Administration

- 7. At the request of the Bills Committee, the Administration agreed to take the following actions -
 - To provide, before the seventh Bills Committee meeting on 9 June 2003, (a) a paper addressing the following points of concern raised on the

proposed indemnity scheme and highlighting the relevant clauses in the Bill with explanations:

Action - 6 -

- (i) Circumstances under which losses would be compensated by the indemnity fund
 - The Administration was requested to illustrate the circumstances with examples, including examples of "mistake" and "omission" referred to in clause 82;
- (ii) Circumstances under which the cap on the indemnity would apply
 - The Administration was requested to illustrate the circumstances with examples;
- (iii) How the indemnity fund was financed;
- (iv) Financial burden to be borne by the Government for the implementation of the proposed indemnity scheme
 - The Administration's response should address the concern expressed by Heung Yee Kuk New Territories (HYK) in its submission dated 21 May 2003;
 - The Administration's response should also provide the required information mentioned in paragraph 6 of the HYK's submission, i.e. the statistics on the amount of indemnity paid to meet indemnity claims in the past in circumstances similar to those which would give rise to a claim for indemnity under the proposed scheme.
- (b) To provide a written response to the submissions received by the Bills Committee on the paper on "Indemnity", in particular the submission dated 22 May 2003 from the Bar and that from Law Soc which would be available in early June.

Other follow-up action

8. The Bills Committee decided that the Bar should be invited to comment particularly on the following point raised in paragraph 30(d) of the Administration's paper on "Indemnity":

"Where the scheme is insufficient to meet the full extent of the loss it does not take away the right that individuals now have to seek personal remedy against the third party fraudster....."

(*Post-meeting note:* An invitation letter was issued to the Bar on 22 May 2003.)
