#### **Broadcasting (Amendment) Bill 2003**

We refer to your letter of 7 January and would like to provide the information requested in accordance with your paragraph numbering.

- (a) Since the other pay TV services are still new to the Hong Kong market, their pirated viewing problem at this juncture may not be as severe as that of HKCTV. However, as far as we understand, the parent company of TV Plus has been suffering from serious pirated viewing problem in Taiwan despite its adoption of digital transmission technology for many years.
- (b) Undeniably, analogue television service is more vulnerable to pirated viewing than digital television service. Nonetheless, it is the experience of HKCTV and its overseas counterparts that in the absence of effective dissuasive and proportionate sanctions, digitization alone cannot contain the pirated viewing problem. For instance, although HKCTV has been carrying out its digital migration as speedily as possible and changing its digital key every couple of days, it notices that:
  - there are still widespread sales of unauthorized digital decoders at Apliu Street. Only in November and December 2003, OFTA seized a large number of unauthorized decoders at Apliu Street. Of those forwarded to HKCTV for testing, 23 devices were intended for decoding our digital service. This contrasts with the Administration's information in its letter to the Bills Committee of 13 January 2004 that there were only 2 digital unauthorized devices seized in the year of 2003.





- there are still widespread promotions and communications on sale,
  installation and use of unauthorized digital decoders in the community.
  Recent flyer distributed in estates and "intelligence" exchanged on the
  Internet are attached for Members' reference.
- unauthorized digital decoders are offered at an increasingly attractive price. The retail price in early 2003 was over HK\$3000 per decoder. It has now dropped to HK\$1200. In addition, a smart card clone is available as cheap as HK\$150.
- lately, certain unauthorized digital decoders have been programmed with an "auto-roll" function which is intended for circumventing HKCTV's periodic changes of its digital key.

The above have arisen notwithstanding the digitisation of our encryption systems because the demand for unauthorized decoders remains strong. Illegal manufacturers have therefore every incentive to circumvent our encryption systems no matter how advanced they may be. To contain the problem, digitization alone is not enough. There must exist effective dissuasive and proportionate sanctions against both the demand and the supply for unauthorized decoders.

- (c) Migration from analogue transmission to digital transmission needs to be carried out building-by-building and is also dependent on the delivery of set top boxes. Thus it takes time to complete the process for the whole territory. Despite that and the hiccups in obtaining additional IBCCDS frequencies for the digital migration in the first year, HKCTV has moved forward on its own initiatives the completion of the digital migration by nine months to the 3<sup>rd</sup> quarter of 2004.
- (d) Since we have been carrying out our digital migration with all speed, there is not much that the Government may do at this juncture to expedite the process. Nonetheless, there remains a lot that the Government may do in curbing pay TV piracy. For instance, the following shortcomings should be addressed immediately.
  - The law enforcers have not given adequate attention to the problem. The law against the supply of unauthorized decoders was promulgated as early



as July 2000. Yet, no enforcement action was taken until January 2001 and only 14 operations were mounted in the following 33 months resulting in the seizure of only 2400 unauthorized decoders. Though there have been seemingly more enforcement actions in the recent months, there remains a concern that such increase was prompted by the desire of getting the above bill passed without significant modification, and the enforcement actions will die down after passage of the bill. Worse still, despite the fact that most (if not all) unauthorized decoders sold in Hong Kong are imported from mainland China, no smuggler has ever been arrested at the border for so many years since the law has existed.

- The Administration has not given the Legco Members full background information for scrutinizing the bill. For instance:
  - the Administration repeatedly advocates that the European Union (EU) legal instruments require sanctions to be imposed only on commercial activities favouring unauthorized reception, not on unauthorized reception per se. However, it fails to point out to the Legco Members that it is the policy of the EU to introduce only a minimum level of legal protection against piracy and to grant Member States flexibility to extend the scope of prohibitions to cater to their own needs. The real intent of the EU requirements has been expressly provided, for example, in paragraph 35 of the Explanatory Report to the European Convention on the Legal Protection of Services based on, or consisting of, Conditional Access (ETS No.:178)² which states that:

"...given that the offences which appear in the Convention are a minimum, Parties are free to go beyond the list of unlawful activities mentioned in Article 4 and may decide that other types of access to a protected service without authorization of the service provider, for example the use of an illicit device for private purposes, should be considered unlawful and subject to penal,

#### administrative or other sanctions." (emphasis added)

- while the Administration repeatedly quoted the Cable and Satellite Broadcasting Association of Asia and Motion Picture Association as the industry associations supporting the Government's gradual approach, it has played down the support for imposing criminal liability upon illicit domestic end-users from many organizations within and without the industry, including:
  - all the local free and pay TV licensees
  - Hong Kong Kowloon & New Territories Motion Picture Industry Association Ltd.
  - Composers and Authors Society of Hong Kong
  - Nagravision SA
  - Association Européenne pour la Protection des Oeuvres et services Cryptés (AEPOC)
  - The Law Society of Hong Kong
  - ♦ The Vocational Training Council

HKCTV agrees that a private-public partnership approach is necessary for curbing pay TV piracy. While the private sector has been making substantial investments and efforts on the technological protection of its property, the provision and implementation of an adequate legal protection by the Administration remains to be seen.
