		ALA1 referred to the second part of section 399(6) of SFO that ", but in any proceedings under this Ordinance before any court the code or guideline shall be admissable in evidence, and if" and invited the Administration to clarify the application of the provision. The Administration advised that it was a common rule of evidence that a non-statutory code or guideline published by a statutory body in relation to its regulatory functions shall be admissable in evidence before the court, though such fact would not form the basis of any prosecution. The provision in section 399(6) only sought to clarify this position in respect of proceedings taken under SFO. The common rule of evidence should however also apply to proceedings initiated under other ordinances. Bills Committee accepted the
