#### I Confirmation of minutes of meeting

- 3. Members noted that the next meeting of the Bills Committee was scheduled for Thursday, 2 October 2003 at 9:00 am to meet deputations. The deadline for submission of views was 22 September 2003.
- 4. Noting that the operation of District Councils (DCs) would likely be suspended in early October 2003 to enable the coming ordinary election to be held, the Bills Committee considered whether an additional meeting should be held in September 2003 to receive views of DCs before the latter suspended operation. The Bills Committee noted that no DCs had indicated interest in submitting views on the Bill so far. After deliberation, the Bills Committee considered that there should be no need to arrange one additional meeting to meet DCs in September 2003. However, the Bills Committee would be prepared to meet DCs if the latter, upon commencement of the next term of office in January 2004, wished to present their views on the Bill to the Bills Committee.

#### Follow-up on outstanding issues of Companies (Amendment) Bill 2002

5. The Clerk would check which issues arising from the Companies (Amendment) Bill 2002 required further study/action by the Administration, and the Administration undertook to provide an update on the progress of the outstanding issues.

#### Work plan of the Bills Committee

6. The Bills Committee considered the proposed work plan outlined in LC Paper No. CB(1)2434/02-03(01), and agreed in principle the proposed arrangement and timetable for the Bills Committee's scrutiny of the Bill. The Bills Committee also agreed on a schedule of future meetings.
