#### I. Meeting with deputations and the Administration

[LC Paper Nos. CB(2)933/03-04(01) and CB(2)1220/03-04(01)]

The deliberation of the Bills Committee was outlined in the index of proceedings at **Annex**.

- 4. Mr SZETO Wah and Mr CHEUNG Man-kwong expressed serious concern about the statement made by the Secretary for Education and Manpower (SEM) at his meeting with representatives of the three primary school councils on 9 February 2004. According to a newspaper report dated 10 February 2004, SEM advised the representatives that in order to provide schools with more flexibility in deployment of funds, the Administration would, after the enactment of the Bill, explore the feasibility of adopting a one-line vote arrangement for provision of recurrent funding to aided schools. Mr SZETO and Mr CHEUNG considered that in adopting a one-line vote

arrangement, Incorporated Management Committees would be able to determine the salaries of principals and teachers without the need to follow the civil service pay system. They requested SEM to provide a written response to clarify the intention of his statement as quoted in the newspaper and the relationship between the Bill and one-line vote arrangement. Mr SZETO also requested parent representatives of parent-teacher associations to consult serving teachers in their schools about the impact of the one-line vote arrangement on the morale of the teaching workforce and the stability of the school environment.

5. The Administration explained that under the existing Codes of Aids for primary, secondary and special schools, staff salaries in aided schools should follow the civil service pay system. Amendment to the Codes of Aids would be made if one-line vote arrangement was to be introduced. The Administration also assured members that if a one-line vote arrangement was considered for adoption, the Administration would consult the Legislative Council and the teaching profession, and would have to obtain the support of the community before implementation.
