#### I. Meeting with the Administration

[LC Paper Nos. CB(2)2601/03-04(01) and (02), CB(2)2613/03-04(01)]

The Bills Committee deliberated (Index of proceedings at **Annex**).

## The "fit and proper" requirement for elected managers

- 2. <u>Members</u> noted the case of Mr FUNG Ka-keung who was elected for appointment as an alumni manager in a Government school in 2002, but so far the Permanent Secretary for Education and Manpower (PSEM) was still considering whether he was a "fit and proper person" for registration as a manager. <u>Members</u> queried whether it was reasonable for PSEM to refuse the registration of an elected alumni manager on the ground that she considered him not a "fit and proper person".
- 3. The Administration explained that the requirement was essential since the electors might not have grasped all the information to determine whether an elected person was "fit and proper" by the time they voted. To safeguard the overall benefits of students in schools, the Administration considered it necessary to retain the provision to ensure that there would be a proper person to exercise the power that the Government devolved to an Incorporated Management Committee (IMC). In response to the Chairman's request, the Administration undertook to provide extracts from relevant ordinances that contained references to the test of "fit and proper".

[*Post meeting note*: the Administration's paper was circulated to members vide LC Paper No.CB(2)2754/03-04(02) on 11 June 2004].

4. <u>Ms Emily LAU</u> considered the "fit and proper" criterion reasonable as there would be circumstances where an elected manager was not suitable for appointment as a school manager. She suggested that the criteria for a candidate to be "unfit or improper" should be set out in the law or guidelines for the reference of candidates and the voters. <u>The Chairman</u> considered the requirement inappropriate and unnecessary for elected managers, and indicated that she would move an amendment to specify that the requirement should not be applicable to elected parent managers and alternate parent managers nominated under proposed section 40AM and elected alumni managers nominated under proposed section 40AN.

#### Clause-by-clause examination

5. The Bills Committee requested the Administration to -

Regulation 66 - Prohibition of collections without permission of Director

(a) refine the drafting of the regulation to reflect more clearly the policy intent;

Regulation 88 - Size of classes

(b) consider exempting aided schools with IMC from regulation 88(c), i.e., no more than 45 pupils should be taught at one time by one teacher, except in the special cases with the permission of PSEM:

Regulation 89 - Hours of instruction

(c) consider exempting IMC schools from the regulation;

Regulation 92 - Syllabus and time-table subject to approval of Director

(d) consider deleting regulation 92(3) or specifying the criteria for PSEM to order the inclusion or exclusion of certain instruction from any syllabus; and examine whether regulation 92(8) and (9) was consistent with the Hong Kong Bill of Rights Ordinance;

#### Regulation 10 - Structural alterations

(e) consider whether the consent of PSEM in writing should be required for any alteration to the latrine accommodation or the sanitary arrangements of a school, or in the ventilation or lighting of its classroom;

#### Regulation 37 - Notice requiring safety equipment against fire

(f) set out the necessary rules and procedures for compliance with fire safety requirements in regulation 37 for IMCs to follow;

#### Regulation 64 - Accounts

(g) consider whether the word "vouchers" in regulation 64(c) included receipts transmitted by electronic means;

#### Regulation 99A - Business or trading operations

- (h) explain the definition and scope of operating business or trading operations on school premises;
- (i) review the need for PSEM to give permission in writing for aided schools to operate business or trading undertaking on school premises; clarify the allocation of the profits to IMC or School Sponsoring Bodies (SSBs) generated from such operation, consult SSBs on the impact of the regulation on school operation, and provide guidelines to schools for compliance with the regulation; and

#### Regulation 21 - Safety precautions

(j) refine the drafting of the regulation to reflect more clearly the policy intent that non-teaching staff such as laboratory technicians should not give instructions in the use of tools, the operation of machines or the conduct of science experiments.

#### Other amendments

6. <u>Members</u> noted that the Administration would consider proposing Committee Stage amendments (CSAs) to regulations 18, 19, 21(2), 47, 48(2) 85, 93, and 95.

7. <u>Members</u> noted that the next meeting would be held on 10 June 2004 at 2:00 pm in Conference Room B.
