## I. Meeting with the Administration

The Bills Committee deliberated (index of proceedings attached at **Annex**).

2. The Bills Committee requested the Administration to provide a written response to the following issues raised and information sought by members -

#### Proposed section 2(1)(b) of the Crimes Ordinance

- (a) deleting the term "instigate" and substituting "incite";
- (b) deleting the expression "the People's Republic of China" and substituting "the territory of the People's Republic of China";
- (c) whether the proposed section, when read with the proposed definition of "foreign armed forces", would exclude instigation of armed forces of Taiwan to invade the Mainland;
- (d) whether requesting the territory of Taiwan to be protected under the missile defence system of the United States or inviting foreign armed forces to enter and protect Taiwan would amount to an offence under the proposed section;

#### Proposed section 2(1)(c) of the Crimes Ordinance

(e) providing explicitly in the proposed section that expressing anti-war views and providing humanitarian aid would not amount to treason;

- (f) explaining with examples the active and passive assistance to a public enemy at war, the types of assistance that would amount to an offence under the proposed section 2(1)(c) and explaining whether being a human shield at the time of war would amount to such an offence;
- (g) improving the drafting of the proposed section, having regard to the following suggestions of members :
  - (i) for the purpose of achieving consistency between the Chinese and English texts;
  - (ii) amending the expression "形勢";

#### Others

- (h) explaining the meaning of the term "intent" in the proposed section 2(1)(a) and 2(1)(c) of the Crimes Ordinance and whether:
  - (i) it referred to subjective intent;
  - (ii) it covered both predominant intent and secondary intent;
  - (iii) recklessness would be regarded as an intent;

The Administration's response to the issues raised and information sought at the joint meeting of the Panel on Security and Panel on Administration of Justice and Legal Services on 17 January 2003 (Paper No. 1)

- (i) providing information on whether the offence of assisting a public enemy at war was found in the relevant legislation of Singapore;
- (j) explaining and providing case law on "joins the enemies in acts of hostility against the country" referred to in page 4 of the paper;
- (k) providing information on the case of *Re Schaefer* referred to in footnote 8 of the paper; and
- (l) explaining whether assisting nationals of an enemy country to leave one's country would amount to "assisting public enemy" under the proposed section 2(1)(c).
- 3. The Administration undertook to provide a paper explaining the meaning of the expression "the People's Republic of China" in the Bill.
- 4. The Bills Committee agreed that a verbatim record should be prepared on the discussion relating to whether the expression "the People's Republic of China" included Taiwan and the Administration's clarification relating to the People's Liberation Army.

5. <u>Mr Martin LEE</u> requested to put on record his view that with a large membership size, the Bills Committee would face the problem of lack of a quorum, if a meeting was too long.

### II. Rescheduling of meeting on 6 May 2003 to 10 May 2003

- 6. <u>The Chairman</u> informed members that as a meeting of the Panel on Security and a joint meeting of the Panel on Manpower and Panel on Administration of Justice and Legal Services would be held in the afternoon of 6 May 2003, he suggested that the meeting originally scheduled for 6 May 2003 be rescheduled to 10 May 2003 from 9:00 am to 12:30 pm.
- 7. Mr Martin LEE disagreed. He said that if the Bills Committee had decided to hold meetings to discuss the Bill with the Administration on Tuesdays, it should stick to such a decision. He considered that the Bills Committee should not hold any meeting in that week to discuss the Bill with the Administration, if such a meeting could not be held in the afternoon of that Tuesday. He added that Saturdays were reserved for meetings to receive the views of the public on the Bill.
- 8. <u>Mr CHAN Kam-lam</u> expressed support for the Chairman's suggestion. <u>Mr Howard YOUNG</u> said that a meeting could be scheduled on 10 May 2003 to discuss the Bill with the Administration, if no member of the public was scheduled for presentation of views to the Bills Committee. <u>Mr Martin LEE</u> said that if the meeting was already scheduled for discussion of the Bill with the Administration, no member of the public would be able to attend the meeting to present views on the Bill.
- 9. <u>The Chairman</u> concluded that the meeting on 6 May 2003 would be rescheduled to 10 May 2003 from 9:00 am to 12:30 pm. He added that consideration could be given to receiving the views of the public on the Bill at the meeting, if such a need arose in the future.

## III. Date of next meeting

- 10. The next meeting would be held on Tuesday, 8 April 2003 from 2:30 pm to 6:30 pm to continue discussion with the Administration.
- 11. The meeting ended at 6:35 pm.
