## I. Meeting with the Administration

The Bills Committee deliberated (index of proceedings attached at **Annex**).

2. The Bills Committee requested the Administration to provide a written response to the following issues raised and information sought by members -

#### **Subversion**

- (a) whether the acts referred to in paragraph 53 of the submission from Hong Kong Bar Association (Submission No. 53) would amount to subversion;
- (b) whether the following acts in Beijing of a Hong Kong Special Administrative Region (HKSAR) permanent resident would be caught by the proposed section 2A(1)(c) of the Crimes Ordinance (CO) -
  - (i) joining movements in the Mainland like the one in Beijing in June 1989;

- (ii) joining supporters of the Association of Falun Dafa in besieging Zhongnanhai (中南海);
- (c) providing a list of the relevant statutory provisions under which the acts referred to in the proposed section 2A(4)(b) of CO were offences in Hong Kong (paragraph B7 of the Schedule to Paper No. 6);
- (d) in the light of doubts raised by the Hong Kong Bar Association, explaining the basis in law for the extra-territorial application proposed in new section 2A(3) of CO;

## Conspiracy and attempt to do acts outside Hong Kong

(e) explaining the effect of the proposed section 2C of CO and whether it was only directed at conspiracy or attempt in Hong Kong of persons who were not HKSAR permanent residents to do acts outside Hong Kong, which would, if done in Hong Kong, be an offence of subversion or secession;

#### **Sedition**

- (f) whether there were any provision in the laws of Hong Kong providing that inciting others to commit an offence was not an offence; and
- (g) whether reference to the act referred to in the proposed section 9A(1)(b) of CO should be included in the proposed section 9C of CO.

## II. Any other business

#### Additional meeting to receive the views of the public on the Bill

The Bills Committee agreed that an additional meeting to receive the views of the public on the Bill would be held on 3 May 2003 from 2:00 pm to 5:30 pm. Chairman reminded the meeting that the deadline for request to make oral representation to the Bills Committee would be 25 April 2003. Miss Margaret NG said that the presentation time of deputations who had spent much time in studying the Bill should not be limited to five minutes. The Chairman said that it was the usual practice that deputations/individuals were each given about five minutes for presentation at meetings to receive the views of the public. He added that after the presentation of views, there would be about one hour which deputations/individuals responded to questions from members, as in the case of the meeting on 12 April 2003.
