I. Meeting with the Administration

The Bills Committee deliberated (index of proceedings attached at **Annex**).

2. The Bills Committee requested the Administration to provide a written response to the following issues raised and information sought by members -

<u>Issues relating to the Official Secrets Ordinance</u>

- (a) to consider providing explicitly in section 13 of the Official Secrets Ordinance (OSO) that the section referred to a member of the security and intelligence services of the Hong Kong Special Administrative Region;
- (b) to explain whether new section 16A(1) of OSO covered information relating to the work or activities of the Ministry of State Security in Hong Kong;

- (c) to provide the relevant parts of the Review of Commonwealth Criminal Law Fifth Interim Report on the Australian equivalent of section 3(2) of OSO;
- (d) to explain the legal effect of sections 5 and 6 of OSO, especially whether the expression "official document" in section 6 of OSO had the same meaning as that in section 5 of OSO;

<u>Issues relating to the proscription of local organizations</u>

- (e) to explain how the assets of a proscribed local organization were to be dealt with:
- (f) to provide information on whether there were references in existing legislation to the expression "Central Authorities";
- (g) to consider whether there was a need to provide for the proscription of a local organization subordinate to an organization proscribed in Macau;
- (h) to explain why the Secretary for Security (S for S) should be given the choice of proscribing a society under section 8 or new section 8A of the Societies Ordinance (SO);
- (i) to explain whether the proscription of local organizations under new section 8A(2)(c) of SO was consistent with human rights protection;
- (j) to explain how new section 8A(2)(c) of SO would operate, and to provide examples to illustrate the circumstances falling outside new section 8A(2)(a) and (b) but within new section 8A(2)(c);
- (k) to consider deleting new section 8A(2)(c) of SO;
- (1) to advise on the Administration's position regarding the suggestion in the submission from Mr Michael BLANCHFLOWER (Submission No. 81) that, in relation to new section 8E of SO, the rules for appeals against S for S's decision to proscribe an organization should be made by the Chief Executive in Council;
- (m) to advise whether there were precedents for the executive authorities to make rules to provide for court procedure; and

(n) to explain whether the passage by the Legislative Council (LegCo) of a bill which amended certain provisions of a piece of legislation implied

that LegCo also endorsed other provisions of the relevant legislation not amended by the bill.

- 3. <u>Miss Margaret NG</u> protested that although many issues relating to previous study areas were still to be raised, discussions on the study area on proscription of local organizations had already commenced. <u>The Chairman</u> said that as there were different views among members on the pace of studying the Bill, members who had finished examining a study area might wish to proceed to the next study area. He stressed that he would not prohibit any member from asking questions on previous study areas.
- 4. The Bills Committee agreed that a verbatim record on the Administration's responses to questions raised by Mr TSANG Yok-sing and Mr Albert HO concerning the application of new section 8A(2)(a), (b) and (c) of SO should be produced.
