I. Meeting with the Administration

The Bills Committee deliberated (index of proceedings attached at **Annex**).

- 2. At the beginning of the meeting, Mr Martin LEE proposed to move a motion urging the Administration to defer the resumption of Second Reading debate on the Bill, and requested that the proposed motion be dealt with immediately. The Chairman suggested that the motion be dealt with under agenda item II "Any other business". As there were divided views among members, a vote was taken on Mr LEE's request. 14 members voted in favour of the request, while 15 members voted against.
- 3. The Bills Committee requested the Administration to provide a written response to the following issues raised and information sought by members -

- (a) to provide members with relevant provisions in existing legislation relating to winding-up;
- (b) in relation to provisions on the winding up of a proscribed local organization, to consider the need to provide for settlement of outstanding salary and other payments liable to be made under the Employment Ordinance after an organization had been proscribed; and
- (c) to provide information on precedents where the Administration made rules to provide for court procedure.
- 4. Secretary for Security said that regulations made under new section 8E of the Societies Ordinance would be subject to the approval of the Legislative Council.
- 5. The Bills Committee requested the Legal Adviser to highlight relevant extracts of the case of *A*, *X* and others *v* Secretary of State for the Home Department.

II. Any other business

6. Mr Martin LEE moved the following motion -

"就本草案而言,政府曾承諾會給予市民充足的諮詢時間,及給予草案委員會充足的審議時間,但基於草案的嚴重性、複雜性及爭議性,以及在此期間發生「沙士」疫症,令公眾未能詳細了解草案的內容,而本草案審議委員會亦未有足夠時間進行公眾諮詢,及未有充足時間完成詳盡和仔細的審議工作,委員會要求政府取消於7月9日恢復二讀辯論的決定,押後提出恢復二讀辯論的日期,以讓公眾有充足機會進行討論,及讓委員會有充足時間進行審議工作。"

- 7. The Bills Committee debated and voted on the motion moved by Mr Martin LEE. Mr Martin LEE requested that the names of members who voted be recorded.
- 8. The following 15 members voted in favour of the motion -

9. The following 24 members voted against the motion -

- 10. The Chairman concluded that the motion was not carried.
- 11. The Chairman suggested that the Bills Committee would commence clause-by-clause examination of the Bill at the next meeting on 14 June 2003 at 9:00 am. As there were divided views among members, a vote was taken on the suggestion. 24 members voted in favour of the suggestion, while 12 members voted against.
- 12. Members noted a letter dated 10 June 2003 from Civil Human Rights Front strongly requesting the Bills Committee to hold meetings to receive the views of the public on the Committee Stage amendments (CSAs) proposed by the Administration. The Chairman said that the Bills Committee had voted against that suggestion at the meeting on 3 June 2003. The Bills Committee had also agreed at the same meeting that individuals and organizations who had expressed views on the Bill to the Bills Committee be invited to give written views, if any, on the CSAs proposed by the Administration.
- 13. Mr James TO suggested that the decision at the meeting on 3 June 2003 that additional meetings would not be held to receive the views of the public on the CSAs proposed by the Administration be rescinded. As there were divided views among members, a vote was taken on Mr TO's suggestion. 12 members voted in favour of the suggestion, while 19 members voted against.
- Mr Martin LEE suggested that the meetings originally scheduled to be held on Saturday, 14 June 2003 at 9:00 am and 2:00 pm be rescheduled to Sunday, 15 June 2003 at 9:00 am and 2:00 pm to avoid clashing with a seminar to be held on 14 June 2003 on the enactment of legislation to implement Article 23 of the Basic Law. As there were divided views among members, a vote was taken on the suggestion. 11 members voted in favour of the suggestion, while 18 members voted against.
- 15. The meeting ended at 7:10 pm.
