The free societies thrive when people are having the absolute rights, right to oppose, right to stop the government, if it is doing some thing wrong. Hong Kong was assumed to be so, only GOD knows how it is today.

It is emphasized here clearly that any laws, which are proposed to be enacted through the faulty consultation-process as already proven here-in...surely do not meet the 'International Criteria' , as repeatedly assured by the HK-Government and such if the 'Blue-Bill' proposed is result of 'defective process' , means it need to be ABANDONED, because it was no-longer FREE AND FAIR consultation and process must be repeated, since there were even other group(s) of Hong Kong people, who were arbitrarily and unlawfully too got excluded and as such this 'Blue-Bill' is NOT result of *ful and fair* 'Lawful Process' or 'Extensive Process' as claimed by the HK-Govt.
