I. Confirmation of minutes of meeting

(LC Paper No. CB(2)2189/02-03)

The minutes of the meeting on 5 May 2003 were confirmed.

II. Meeting with deputations

(LC Paper No. CB(2)2241/02-03)

- 2. <u>Members</u> noted that a total of 53 written submissions on the Bill from various organisations/individuals had been received by the Bills Committee. 12 representatives from 10 organisations attended the meeting to make oral representations on their written submissions.
- 3. <u>The Bills Committee</u> received views from the deputations attending the meeting.

Electoral Affairs Commission (EAC)

4. <u>Members</u> noted the concern expressed by some deputations that EAC had exercised excessive power in regulating election-related activities, such as in compelling compliance with the equal time principle in relation to media interviews of election candidates. <u>Members</u> agreed that the Panel on Constitutional Affairs might follow up the issue of the function and power of EAC. <u>Ms Audrey EU</u> also suggested that the Research and Library Services Division might be requested to conduct a research to compare the function and power of EAC with that of similar bodies in overseas jurisdictions.

6. <u>The Bills Committee</u> requested the Administration to provide written response to the following issues -

(a) Review of the drafting of the Chinese version of the proposed new definition of "elector" in section 3(1) of the Legislative Council Ordinance (Cap. 542);

Clause 3(1) and (2)

(b) Review of the drafting of the proposed amendment to section 8 of Cap. 542;

Clause 11

(c) Review of the composition of the Tourism Functional Constituency (FC). As pointed out by Mr Howard YOUNG, some travel industry members of the former Hong Kong Tourist Association (HKTA) might not be eligible to register as electors in the Tourism FC. The Administration was requested to respond to Mr YOUNG's proposal that the status of the travel industry members of the former HKTA which were previously eligible electors in the Tourism FC should be grandfathered;

Clause 12

- (d) Explanation of the criteria for accepting applications for registration as electors in the Sports, Performing Arts, Cultural and Publication FC; whether any applications for registration had been refused and if so, the reasons for rejection;
- (e) Review of the drafting of section 20V(1)(e) of Cap. 542 to clarify which Provisional Regional Council the section was referring to. As pointed out by Ms Miriam LAU, there were two Provisional Regional Councils, one existing between 1985 and 1986, and the other from 1 July 1997 to 31 December 1999;
