I. Confirmation of minutes of meeting

(LC Paper No. CB(2)2406/02-03)

The minutes of the meeting on 15 May 2003 were confirmed.

2. <u>The Bills Committee</u> deliberated (index of proceedings attached at **Annex**).

Continuation of clause by clause examination of the Bill

3. <u>The Bills Committee</u> concluded clause by clause examination of the Bill.

Adjustments to the electorate of information technology functional constituency (IT FC)

(LC Paper No. CB(2)2436/02-03(02))

4. <u>Dr Raymond HO and Mr SIN Chung-kai</u> noted that the Administration had proposed to add seven umbrella organizations to IT FC. They expressed particular concern about the proposal to include the Hong Kong & Mainland Software Industry Cooperation Association (HMSICA) which enabled both corporate members and certain individual members (i.e. Council Members) of HMSICA to become electors of IT FC. They pointed out that the proposal was inconsistent with the approach for delineating the franchise in respect of

other trade associations which had already been included in the IT FC, where only the corporate members of the associations could become electors of the IT FC.

Follow-up actions required of the Administration

- 5. The Administration was requested to -
 - (a) in relation to the proposed delineation of franchise for HMSICA, review the Administration's proposal to allow both corporate members and Council Members of HMSICA to become electors of the IT FC; and
 - (b) provide an updated set of draft Committee Stage amendments for the consideration of the Bills Committee.

(*Post-meeting note* - The Administration's written responses were circulated vide LC Paper Nos. CB(2)2480/02-03(01) and (02) dated 5 June 2003.)

Date of resumption of Second Reading debate on the Bill

6. <u>Some Members</u> proposed that the Second Reading debate on the Bill be resumed at the Council meeting on 2 July 2003. As the date for the Administration to consult the Chairman of the House Committee on the resumption of the Second Reading debate on the Bill at the Council meeting on 2 July 2003 was 10 June 2003, <u>Mrs Selina CHOW</u>, Chairman of the House Committee, advised that she had no objection to the Administration issuing a letter to consult her on the resumption date before the House Committee meeting on 13 June 2003, and the Chairman of the Bills Committee making a verbal report on the resumption date to the House Committee on 13 June 2003. The Bills Committee could report its deliberations on the Bill to the House Committee on 20 June 2003.
