I. Confirmation of minutes of previous meeting

The minutes of the meeting held on 17 October 2003 were confirmed.

II. Meeting with the Administration

2. The Bills Committee deliberated (index of proceedings attached at **Annex**).

Administration's response to issues raised by members at the meeting on 17 October 2003

(LC Paper No. CB(2)188/03-04(01))

3. <u>Ms LI Fung-ying</u> expressed disappointment that the Administration would not provide any undertaking that the fee charging principle for determining the test fee for the electrical and mechanical (E&M) trade tests would be the same as that for the fees of the construction trade tests. <u>Ms LI</u> said that although the Administration had explained to members that the same fee-charging principle would likely be extended to the E&M trade tests, in the absence of an undertaking, the principle for determining the E&M test fee could be revised later. <u>Ms LI</u> urged that the Administration should

adopt remedial measures to ensure that the future fee charging principle for determining the test fee for the E&M trade tests would be the same as that for the fees of the construction trade tests. Principal Assistant Secretary for Education and Manpower (PAS(EM)) responded that the Executive Director of the Construction Industry Training Authority (CITA), who was also present at the meeting, would relay members' concern over the test fees to the CITA Board.

- 4. <u>Ir Dr Raymond HO</u> held a strong view that the number of seats allocated to the Hong Kong Institution of Engineers (HKIE) on the CITA Board should not be reduced from two to one. <u>Dr HO</u> commented that HKIE had not been consulted on the proposal.
- 5. <u>PAS(EM)</u> said that the proposed changes to the composition of the CITA Board were considered by the CITA Board which consisted of two HKIE representatives. The relevant minutes of meeting reflected that the proposal to reduce the number of seats allocated to HKIE from two to one had received unanimous support from the CITA Board at its meeting held in May 2002. <u>PAS(EM)</u> further said that the proposal was in fact conceived by the industry. <u>PAS(EM)</u> added that, apart from the CITA Board, the Provisional Construction Industry Co-ordination Board (PCICB) which had a wide representation from the construction industry also endorsed this proposal. The Administration was of the opinion, given the representativeness of these two construction industry related organizations, the industry had been adequately consulted.

(*Post meeting note*: The Administration has provided the extract from the minutes of the CITA Board meeting held on 16 May 2002 after the meeting, which is attached.)

- 6. <u>Ir Dr Raymond HO</u> disagreed with the Administration's remarks that the proposal received unanimous support from the CITA Board. He pointed out that to his knowledge, the two HKIE representatives opposed the proposal at the CITA Board meeting in May 2002. <u>Dr HO</u> said that discussion of the proposal by the CITA Board and PCICB, which were advisory bodies, was by no means consulting the stakeholders in the industry. HKIE, being stakeholder, should be formally consulted. <u>Dr HO</u> stated that he would not support the Bill if the Administration did not accede to retaining the two seats presently allocated to HKIE on the CITA Board.
- 7. Mr LEUNG Fu-wah considered that organisations and professional bodies affected by the proposed changes to the composition of CITA Board should be directly consulted, instead of indirectly through their respective representatives on the Board. Ms LI Fung-ying and Mr CHAN Kwok-keung considered that as HKIE was directly affected by the proposal, it should be properly consulted. To address Dr Raymond HO's concern, Mr CHAN Kwok-keung suggested that the Administration might consider increasing the membership of the CITA Board from 13 to 14. Mr Abraham SHEK expressed support for the suggestion.
- 8. The Bills Committee requested the Administration to consider expanding the

composition of the CITA Board from 13 members to 14 members so that the existing two seats for HKIE on the CITA Board would be retained.

Amendments proposed by the Administration

9. The Bills Committee noted that having considered the concern raised by the legal adviser to the Bills Committee, the Administration would propose amendments to clause 5 of the Bill to reflect more clearly the policy intent that a person would be regarded as a person who occupied or owned a domestic premises if he occupied or owned any part of the premises.

III. Date of next meeting
