#### Action

## I. Meeting with the Administration and deputations

[LC Paper Nos. CB(2)2198/02-03(01) to (12), CB(2)2233/02-03(01) and CB(2)2248/02-03(01) to (12)]

The Bills Committee deliberated (Index of proceedings attached at Annex).

2. The Bills Committee received the views from the following 25 deputations and individuals on the Bill -

- Adm 3. <u>The Administration</u> was requested to provide a written response to the views and concerns of deputations expressed in their submissions and at the meetings of the Bills Committee.

## II. Any other business

### Future meetings with deputations

4. <u>Members</u> noted that a total of 93 deputations and individuals had requested to present views on the Bill. To allow more time for the exchange of views among members, deputations and the Administration, <u>members</u> agreed that -

- (a) in addition to the meetings scheduled for 10 and 13 June 2003, the Bills Committee would also receive public views at its meeting on 16 June 2003;
- (b) 27 deputations and individuals would be invited to the meeting scheduled for 8:30 am on Tuesday, 10 June 2003 to present their views on the Bill as agreed at the last meeting on 23 May 2003, and the meeting would be extended for half an hour to end at 11 am;
- (c) a maximum of 20 deputations only should be invited to each of the meetings scheduled for 13 and 16 June 2003; and
- (d) each deputation and individual should be requested to provide submissions before the meeting concerned and make brief oral presentation of their views at the meeting within four minutes.

5. At Mr Andrew CHENG's request, <u>members</u> also agreed that representatives of the Hong Kong Professional Teachers' Union, the Great Coalition to Oppose Legalization of Soccer Betting and the Hong Kong Christian Anti-Soccer Gambling Alliance, and Mr CHUNG Kim-wah would be invited to the meeting to be held on 16 June 2003 for further discussion of their views on the Bill with members. <u>The Chairman</u> suggested that to facilitate the discussion, Mr CHENG should put in writing the issues he wished to raise with the deputations concerned and Mr CHUNG Kim-wah so that they might respond in writing.

### Date of next meeting

6. <u>Members</u> noted that the next meeting would be held on Friday, 6 June 2003 at around 5:15 pm immediately after the meeting of the House Committee scheduled for 4 pm on the same day.

7. There being no other business, the meeting ended at 1:25 pm.
