I. **Meeting with the Administration**

Committee Stage amendments (CSAs) to be proposed by the Administration and members

[LC Paper Nos. CB(2)2531/02-03(02) and CB(2)2603/02-03(02)]

The Committee deliberated the draft CSAs to be proposed by the Administration and the second draft CSAs to be proposed by Ms Cyd HO (index of proceedings attached at **Annex**).

Adm 2. The Administration undertook to -

- include conflict of interest as one of the consideration for the (a) Secretary for Home Affairs (SHA) to determine whether the licensed operators of authorized football betting and lotteries and their related persons were fit and proper under the proposed new 6AAA section in the draft CSAs to be proposed by the Administration;
- make reference to the wording of section 20E of the Legislative (b) Council Ordinance (Cap. 542) and section 4 of the Human Reproductive Technology Ordinance (Cap. 561) and consider

amending the draft CSA to the proposed new section 6B on the inclusion of one member each from the education, social welfare and religious sectors in the composition of the "Football Betting and Lotteries Commission";

- (c) give an undertaking in the speech to be delivered by SHA during the resumption of the Second Reading debate on the Bill that the placing of hedging bets by a football betting conductor would be closely monitored and set out the areas that would be included in the hedging policy submitted by a football betting conductor; and
- (d) consider specifying in the proposed new section 6R that it was an offence for any person even to give away a football betting ticket to a juvenile.
- 3. Ms Cyd HO informed members that since she agreed to the draft CSAs to be proposed by the Administration to the proposed new section 6B regarding the appointment of the Chairperson and filling of vacancies in the membership of the Football Betting and Lotteries Commission, as well as the draft CSAs to the proposed new section 6E regarding the transaction of business of the Commission by circulation of papers, she would not propose CSAs to these subsections. However, she said that as the Administration did not agree to postpone the commencement of the Amendment Ordinance, she would propose a CSA to clause 1(2). She added that if the Administration did not accept her proposed description of the three members to be added to the composition of the Football Betting and Lotteries Commission in paragraph 2(b) above, she would propose CSAs accordingly.

Outstanding issues arising from previous meetings [LC Paper Nos. CB(2) 2603/02-03(04) and CB(2)2609/02-03(01)]

- 4. The Committee deliberated the Administration's response to the issues and concerns raised by members at the meeting on 18 June 2003 (index of proceedings attached at **Annex**).
- 5. <u>Members</u> agreed that the Administration's response to the outstanding issues arising from, and to the views of the deputations expressed at, previous meetings should be discussed at the next meeting on 24 June 2003. <u>Members</u> also noted that the research team of the Hong Kong Polytechnic University conducting the study on Hong Kong people's participation in gambling activities in 2001 had been disbanded and that one of the team members had attended meetings of the Bills Committee twice to present his personal views on the Bill. In view of the above, <u>members</u> agreed that it was not necessary to arrange for a briefing on the study at the next meeting and members might refer to the report of the study provided by the Administration for details of the study. <u>Members</u> noted that representatives of the Education and Manpower Bureau

would be invited to brief members on the education measures implemented by the Bureau to prevent gambling-related problems at the next meeting.
