I. Meeting with the Administration

1. The Bills Committee deliberated (index of proceedings attached at **Annex**).

2. The Bills Committee requested the Administration to provide a written response to the following -

- (a) to explain the legislative intent of section 5(3) of the Adoption Ordinance (AO), the reasons for proposing the change, the effect of the proposed deletion on the matters to be considered by the court when considering whether to make an adoption order, and whether similar legislative provisions as the existing section 5(3) were found in other jurisdictions;
- (b) to explain the mechanism for the adoption of a child by an overseas applicant before and after the Bill was enacted, and highlight the differences between a "Convention adoption" and a "non-Convention adoption" as referred to in paragraph 13 of Annex F to the Legislative Council Brief on the Bill;
- (c) to provide the list of organisations which had expressed views in the public consultation exercise on the Administration's proposed amendments to AO in 1998-99, the differences between the proposals in 1998-99 and those in the Bill, and the proposals in the Bill not covered by that consultation; and
- (d) to provide information on the membership of the working group formed to consider the proposals on adoption, and the proposals in the Bill with which the working group had been consulted.

3. The Chairman requested that, as a general rule, the Administration should, when responding to issues raised by the Bills Committee on a proposal in the Bill, explain the policy behind the proposal, consultations made on the proposal and the views collected. It should also give an explanation of the proposed amendments to implement the proposal.

4. The Bills Committee agreed that the views of the following organisations should be sought on the Bill -

- (a) International Social Service (Hong Kong Branch);
- (b) Mother's Choice;
- (c) The Law Society of Hong Kong;
- (d) Hong Kong Bar Association; and
- (e) Hong Kong Family Law Association.

5. The Bills Committee noted that the next meeting had been scheduled for 18 February 2004 at 10:45 am.
