I. Meeting with the Administration

- 2. The Bills Committee requested the Administration -
 - (a) to advise whether there were residence requirements on adoption in the relevant legislation of the United States;
 - (b) to provide information on the number of Mainland children who had settled in Hong Kong after adoption by Hong Kong residents;
 - (c) to provide its response to issues raised in the submission from Caritas Hong Kong;
 - (d) to consult other non-government organisations (NGOs), including Caritas
 Hong Kong, on the proposed arrangements in its paper entitled "Local Adption Choice for Birth and Prospective Adoptive Parents and the participation of NGOs" and inform members of the outcome of its consultation;
 - (e) to consider allowing more NGOs to engage in adoption arrangements;
 - (f) to consider deferring the commencement of the part of the Bill on private arrangements for adoption by unrelated persons until the relevant mechanism was established;

- (g) to consider specifying in the Adoption Ordinance (AO) the list of accredited NGOs or the criteria for accreditation of NGOs;
- (h) to explain the intent of the proposed section 5(1)(c)(ii) of AO and consider whether there was a need for the proposed section;
- (i) to consider improving the drafting of the proposed section 5(1) and 5(2) of AO to minimise the need for references to other sections of AO;
- (j) to advise, in the situation where the birth mother of a child had died but the birth father was still alive, on the channel for a step father aged under 25 to adopt the child;
- (k) in relation to the proposed section 5(8) of AO, to consider providing that the court might regard a continuous custody as not broken in circumstances where it considered reasonable: and
- (l) to consider amending the expression "continuous actual custody" in the proposed section 5(8) of AO as "continuous actual care and control".
