## I. Meeting with the Administration

- 1. The Bills Committee deliberated (index of proceedings attached at **Annex**).
- 2. The Bills Committee requested the Administration -
  - (a) to consider amending the expression "in such amount as may be approved by the Director" in the proposed section 22(1)(b) of the Adoption Ordinance (AO) along the lines of "in accordance with the fees set by the Director from time to time";
  - (b) to explain the intent of the proposed section 23A(1B) of AO, the definition of the expressions such as "duly authorized" and "competent authority" in the proposed section, and how the proposed section was to be implemented;
  - (c) to consider amending the expression "any negotiations of which the purpose or effect is" in the proposed section 23A(3)(b) of AO along the lines of "negotiations the purpose or effect of which is";

- (d) to consider defining the term "natural relative" in the proposed section 23C(1) of AO;
- (e) to consider deleting the expression "on the ground that" in the proposed section 26(4)(b) of AO;
- (f) to consider amending the expression "outside Hong Kong" in the proposed section 28(4)(a) of AO along the lines of "outside the People's Republic of China";
- (g) to consider amending the proposed section 29A of AO to differentiate between -
  - (i) placement by the Director of Social Welfare and placement by an accredited body;
  - (ii) cases where specific consent was given and those where there was no specific consent; and
- (h) to consider amending paragraph 2 of the proposed Schedule 4 of AO, having regard to the views expressed by members.
- 3. The Bills Committee agreed that the following meetings would be scheduled to continue discussion with the Administration -
  - (a) Monday, 7 June 2004 at 10:45 am; and
  - (b) Thursday, 10 June 2004 at 4:30 pm.
- 4. The meeting ended at 6:40 pm.
