# NOTE FOR ESTABLISHMENT SUBCOMMITTEE OF FINANCE COMMITTEE

Consolidated Return on the Creation and Deletion of Civil Service Posts in the Hong Kong Monetary Authority for 2002-03

#### INTRODUCTION

Establishment Subcommittee Paper EC 1992-93 Item 41 requires the Chief Executive of the Hong Kong Monetary Authority (HKMA) to submit annually a consolidated return on the number of civil service posts created and deleted during the year.

#### **BACKGROUND**

2. The HKMA was established on 1 April 1993 through a merger of the then Office of the Exchange Fund and the Office of the Commissioner of Banking. All civil servants of the relevant offices then, together with their posts, were transferred to the HKMA. The Finance Committee delegated, vide Paper EC 1992-93 Item 41, to the Chief Executive of the HKMA the authority, subject to the approval of the Financial Secretary on the advice of the Exchange Fund Advisory Committee, to create and delete non-directorate civil service posts. The creation of directorate civil service posts in the HKMA as well as the appointment and promotion of staff to fill civil service posts in the HKMA are subject to the normal civil service rules and procedures.

#### CIVIL SERVICE POSTS CREATED AND DELETED IN 2002-03

- 3. The civil service establishment of the HKMA as at 1 April 2002 is Encl. 1 at Enclosure 1.
  - 4. Within the financial year 2002-03, a total of six civil service posts were deleted due to natural wastage of the incumbents, resulting in a total of 84 civil service posts remaining as at 31 March 2003. A list of the posts deleted is at Enclosure 2.
