Reply:

1. To enhance the effectiveness of the assessment mechanisms in facilitating learning and teaching, the Education Commission proposed in its education reform document in 2000 to introduce Basic Competency Assessments in Chinese, English and Mathematics (BCA) to

- a) enable teachers and parents to understand students' learning needs and problems so as to facilitate timely assistance.
- b) provide the Government and school management with information on schools' standards in key learning areas so that the Government will be able to provide support to those schools in need of assistance, and to monitor the effectiveness of education policies.

The proposed BCA will comprise two parts, namely Student Assessment and System Assessment.

Student Assessment will mainly be conducted on-line. It serves to provide schools with an additional effective tool for conducting internal assessment. Schools may make use of this type of assessment to supplement other modes of internal assessment (including paper-and-pencil tests and observing students' performance in learning activities and project work) according to students' needs, so as to monitor students' learning progress and needs, more comprehensively and effectively, thus facilitating early detection of problems and timely provision of guidance and support.

System Assessment will be administered centrally and conducted at the territory-wide level. It serves to provide information on the extent to which individual school has attained the basic standards in the key learning areas. This would help schools formulate plans to improve the effectiveness of learning and teaching on the basis of the assessment data and their own development needs. The System Assessment will also provide information about the basic standards of learning in Chinese, English and Mathematics in the territory.

Question Serial No. S019 The prototype of the Student Assessment was launched in mid 2002. Some 114 primary schools are now given access to the on-line system. In mid 2003, all primary schools will have access to the Student Assessment programme. Secondary schools will have access to the system for Secondary 1-3 students by mid 2004.

The System Assessment is still in the design stage. The first System Assessment will be administered at P3 level in mid 2004, followed by that at P6 level in 2005, and S3 level in 2006.

2. The Education and Manpower Bureau (EMB) is the policy owner of the initiative while the Hong Kong Examinations and Assessment Authority (HKEAA) is the agent to develop the BCA for the Government under a contract agreement signed in 2000. EMB co-ordinates and monitors work on BCA, and provides funding to HKEAA according to the contract agreement

3. The contract agreement between EMB and HKEAA was signed in 2000 covering the entire development time of the BCA project from 2001 to 2006. We spent \$37 million in 2002-2003 and expect to spend an estimated \$37 million in 2003-04. Breakdown of the expenditure item is given below:

Reply:

(a) The Education (Amendment) Bill 2002 provides for, among other things, the establishment of Incorporated Management Committees (IMC), their composition, operation, functions and powers as well as transitional arrangements before the establishment of IMCs. When the Bill is passed, all aided schools will have to incorporate their management committees before the end of a five-year transition period. We plan to publicize details of the participatory, transparent and accountable school governance framework through briefings, roving exhibitions, leaflets and TV Announcements of Public Interest. We will also provide necessary support to help schools comply with the requirements, such as provision of a sample IMC constitution, election guidelines for parent and teacher managers and a School Managers' Handbook. Training for school managers will be organised on an on-going basis. Apart from an estimated expenditure of \$1.6m on proposed publicity activities, there are no recurrent financial and staffing implications for the Government arising from the implementation of the new governance structure. Workload related to processing applications for incorporation, vetting IMC constitutions and other related matters will be absorbed by the Bureau through redeployment of existing resources.

- (a) The expenditure for adult education courses operated by the Education and Manpower Bureau (EMB) for the 2002-03 financial year is \$71m.
- (b) EMB is planning to commission operators to run the existing adult education courses for two years starting from September 2003. The expenditure for the 2003-04 financial year will depend on the outcome of the tendering exercise on outsourcing of the adult education courses.
- (c) In recent years, the Government has introduced various initiatives to provide more education and training opportunities for the adult learners. These include, among others, the Continuing Education Fund, Senior Secondary Schools, Project Yi Jin, Workplace English Training Courses, Youth Pre-employment Training Programme, Youth Work Experience and Training Scheme, Skills Upgrading Scheme, Retraining Courses of Employees Retraining Board and courses of Vocational Training Council. It is also observed that the overall dropout rate of the adult education courses operated by EMB has increased from 22% in the 2000/01 school year to 29% in the 2001/02 school year. We therefore estimate that there will be a drop in enrolment on formal adult education courses in the 2003/04 school year.

Reply:

There is no immediate need to allocate additional resources to engage the service of experts in sustainable development/environmental protection to support schools in these aspects as the existing provision is found to be adequate.

First, it is the standing policy of the Education and Manpower Bureau (EMB) to promote environmental education (EE) and sustainable development (SD) at all levels of school education through the curriculum. There are a total of 28 school subjects (5 primary and 23 secondary) including two newly introduced subjects entitled Integrated Humanities (綜合人文科) (S4&5) and Science and Technology (科學與科技科) (S4&5), which have incorporated environmental education and sustainable development elements. In compiling these subject curricula, experts with environmental education and sustainable development background from different sectors, including tertiary institutes and non-government organizations, have been deeply involved.

In addition, EMB also publishes reference materials and develops web-based resources to assist schools to formulate EE and SD programmes. Regular school visits to provide on-site advice on promotion of EE and SD in schools are conducted.

Furthermore, EMB also works closely with various government departments, green groups, tertiary institutes and draw on their expertise to organize different types of teacher development programmes and school activities to strengthen schools' competency to promote EE and SD in schools.

These measures have proved effective in helping schools to enhance the awareness in promoting EE and SD which have been gaining popularity in the school sector, as reflected in the increasing number of participating students and schools. To cite an example, the Waste Separation and Recycling Scheme in schools has had the active participation of 1196 primary and secondary schools (about 96%) in 2002/2003, as compared with a total of 400 participating primary and secondary schools (about 32%) in 1999/2000.

Based on the return of actual expenditure from the three institutions offering subdegree programmes (i.e. CityU, PolyU and HKIEd) for the 2001/02 academic year, the public subsidy for the 12,201 subdegree places in the year after netting off the tuition fee is about \$1,534m.

We have not received information on the actual spending of the programmes which is normally not available until the end of the years. For 2004/05 and 2005/06, which are not within the current 2001-2004 triennium, the number of places available and the funding arrangement are as yet undecided.
