Priority allocation of a debate slot to the Select Committee on Building Problems of Public Housing Units

Purpose

This paper invites the House Committee to consider the request of the Select Committee on Building Problems of Public Housing Units (the Select Committee) for priority allocation of a debate slot to move a motion for debate on its first report on 12 February 2003.

Background

- 2. On 7 February 2001 the Council appointed by resolution a select committee to inquire into the building problems in Tin Chung Court, Shatin Area 14B Phase 2, Shek Yam Estate Phase 2 and Tung Chung Area 30 Phase 3 and to identify recommendations to improve the quality of public housing at institutional and policy levels. A copy of the resolution passed by the Council is in **Appendix I**.
- As at the date of this paper, the Select Committee has held 70 hearings and 115 meetings. Save for the circumstances surrounding the Tin Chung Court incident, the Select Committee has completed inquiry of the matters specified in the resolution which appointed it. Lately the Select Committee has obtained new information in relation to the Tin Chung Court incident which has bearings on its findings and observations. It therefore needs more time to examine the new information. In order not to delay reporting its work to the Council, the Select Committee has decided to make its first report to the Council at the meeting on 22 January 2003. The first report covers its findings on the overall policies and

system of public housing and the incidents on Shatin Area 14B Phase 2, Shek Yam Estate Phase 2 and Tung Chung Area 30 Phase 3, and its recommendations arising therefrom.

Motion debate on the first report of the Select Committee

- 4. The matters inquired by the Select Committee are of wide public concern. The findings and observations made by the Select Committee will serve as a future reference for avoiding the same building problems uncovered in the incidents and improving the quality of public housing. For the purpose of enabling Members and public officers to express views on the findings and observations of the Select Committee, the Select Committee has decided that the Chairman on its behalf should move a motion debate on its first report on 12 February 2003. The wording of the motion is in **Appendix II**
- 5. For Members' reference, it has been the practice for the chairman of a select committee to move a motion to endorse the report of the select committee after its tabling in the Council.

Priority allocation of a slot to debate the first report of the Select Committee

- 6. The newly added House Rule 14A provides for the arrangements for allocation of slots for debates to chairmen of committees of the Council. House Rule 14A(h) stipulates that committees and subcommittees of the Council may make a request for priority allocation of debate slots which shall be considered by the House Committee on a case-by-case basis. Should the House Committee accede to such a request, the debate slot shall not be counted as the mover's own motion.
- 7. Pursuant to House Rule 14A(h), the Select Committee requests the House Committee to consider priority allocation of a debate slot to its Chairman to move a motion for debate on its first report at the Council meeting on 12 February 2003.

Advice sought

8. Members are invited to consider the request of the Select Committee in paragraph 7 above.

That this Council appoints a select committee to inquire into the building problems in the production of public housing units having regard to the circumstances surrounding the incidents in Tin Chung Court, Shatin Area 14B Phase 2, Tung Chung Area 30 Phase 3 and Shek Yam Estate Phase 2, and based on this to identify positive recommendations for a complete overhaul of the overall policies and system of public housing, which should include examining whether the Housing Authority should be reorganized, split or abolished, so as to raise the quality of public housing; and that in the performance of its duties the committee be authorized under section 9(2) of the Legislative Council (Powers and Privileges) Ordinance (Cap. 382) to exercise the powers conferred by section 9(1) of that Ordinance.
