**Parliamentary Liaison Subcommittee**

**Membership of the Legislative Council delegation  
to visit Singapore and Thailand**

**Purpose**

This paper informs the House Committee of the membership of the Legislative Council delegation to visit Singapore and Thailand.

**Background**

2. At the meeting held on 14 February 2003, the House Committee endorsed the recommendation of the Parliamentary Liaison Subcommittee that a visit to Singapore and Thailand should be held from 23 to 29 April 2003. The House Committee also noted that the selection of Members to form the delegation would be in accordance with the method set out in LC Paper No. CB(3) 339/00-01 agreed on 19 January 2001, i.e. Members are divided into six defined groups and each group of Members will nominate the Member(s) to occupy the allocated place(s) in accordance with its own method.

**The delegation**

3. In response to the Secretariat's circular on forming the delegation, the following Members have been nominated by the respective groups to take part in the visit:
