Further to the meeting of the LegCo Panel on Food Safety and Environmental Hygiene (FSEH) held this Monday, I write to inform you of the Administration's intention to withdraw the original motion scheduled for the LegCo sitting on 18 June 2003. This is to enable the Administration to include in an amended resolution dog fouling and illegal posting of bills under the proposed increase in fixed penalty, as suggested by Members of the Panel and the public.

I understand the original motion has been scheduled for discussion by the House Committee on 6 June 2003 and I have therefore taken the liberty to copy this letter to the Chairman of the House Committee to keep her informed of the latest development.

It remains the Administration's intention to move the amended resolution on 18 June 2003 and, in this connection, I would be very grateful to have the support of the FSEH Panel and the House Committee in seeking a waiver from the President of the Legislative Council on the notice requirement.

Explanatory Note

The purpose of this Resolution is to increase the fixed penalty in relation to the following offences from \$600 to \$1,500 -

- (a) display of bills or posters without permission;
- (b) depositing of litter or waste in public places;
- (c) spitting in public places;
- (d) fouling of street by dog faeces;
- (e) depositing of litter in country parks and special areas;
- (f) spitting in country parks and special areas;
- (g) marine littering; and
- (h) unlawful depositing of waste.
