Report of the Subcommittee to follow up the outstanding capital works projects of the former municipal councils

Purpose

The paper summarises the progress of work of the Subcommittee to follow up the outstanding capital works projects of the former municipal councils, and seeks Members' views on the way forward.

Background

- 2. Upon the dissolution of the two Provisional Municipal Councils (PMCs) in January 2000, a subcommittee was set up under the House Committee to follow up the outstanding capital works projects of the PMCs. The subcommittee was dissolved at the end of the first Legislative Council (LegCo) term after reporting to the House Committee on 23 June 2000. At the beginning of the second term, a new subcommittee was set up under the House Committee to continue to follow up the outstanding projects.
- 3. Chaired by Dr Hon TANG Siu-tong, the Subcommittee has, since November 2000, held 16 meetings with the Administration. The Subcommittee has also considered views given by the District Councils (DCs). The membership list of the Subcommittee is in **Appendix I**.

Progress made

Projects which had obtained funding approval of the Provisional Municipal Councils

4. Upon the enactment of the Provision of Municipal Services (Reorganisation) Ordinance in December 1999, the Finance Committee approved on 17 December 1999 the direct inclusion into Category A of the

Public Works Programme (PWP) 149 projects which had been contractually committed by the PMCs. The Finance Committee also agreed to fast track for direct injection into Category A of PWP 12 projects which had obtained funding approval of the PMCs but not yet contractually committed, subject to the views of the relevant LegCo Panels and the advice of the Director of Architectural Services on the readiness of the projects to proceed. Following discussion by the former subcommittee in the first term, nine of these 12 projects were upgraded to Category A of PWP in 2000.

- 5. The Subcommittee set up in the second term continued to urge the Administration to expedite implementation of the three remaining projects, i.e. the Stanley Complex, Hammer Hill Road District Park and Kowloon Bay Recreation Ground. The Subcommittee also gave a number of suggestions on the design and the use of the proposed facilities. These projects, with a revised design, were upgraded to Category A of PWP in 2002.
- 6. The Subcommittee's discussion in respect of the three projects was summarized in paragraphs 7 to 15 below.

Stanley Complex

- 7. The Administration informed the Subcommittee that it had re-assessed the need for a new market in the Stanley Complex, and conducted two surveys in March and August 2000. According to the findings of the second survey, there was a marked change in the shopping habits of the Stanley residents and substantial reduction of patronage of the existing temporary market. The Administration therefore proposed to retain the existing temporary market at the seafront i.e. the Stanley Temporary Market, and to provide a new style complex comprising a sports arena, a multi-purpose hall, a small library and a sub-office of Southern District Office in the Complex.
- 8. Some members of the Subcommittee pointed out that the residents of Ma Hang Estate had strongly demanded for a permanent public market in the district as new superstores could not substitute for wet markets. However, in order not to further delay the implementation of the Stanley Complex project which would provide community and sports facilities for residents in Stanley, these members supported the revised design on the condition that a permanent market would be provided for the district. They suggested that the existing temporary market could be converted to a permanent market, and the seafront could be developed into a tourist area.
- 9. Having considered members' views, the Administration informed the Subcommittee that it would carry out improvement works to the Stanley Temporary Market to enhance its business environment and seek the approval of the Town Planning Board to retain the temporary market on a permanent basis. The Subcommittee was subsequently informed that the Metro Planning

Committee of the Town Planning Board had approved the application to retain the Stanley Temporary Market for a period of three years. The Subcommittee expressed reservation about retaining the temporary market for only three years, and urged the Administration to provide a permanent market in Stanley.

10. The Stanley Complex project was upgraded to Category A of PWP in November 2002.

Hammer Hill Road District Park

- 11. The Subcommittee had urged the Administration to provide the design and estimated costs of the project for discussion. Members generally agreed that the design of the District Park should be compatible with that of Chi Lin, so that the area could become a major tourist spot. The Subcommittee was subsequently informed that Chi Lin Nunnery would be entrusted with the design work. The Subcommittee received a briefing on the design proposed by Chi Lin and members expressed appreciation of the design. Some members suggested that there should be more natural greening than artificial landscaping and pavilions. They also reminded the Administration to provide sufficient carpark and toilet facilities to cater for large numbers of visitors.
- 12. As regards the project costs, members considered that the costs to be borne by the Administration should not exceed the original budget of \$177 million (at MOD prices) previously approved by the former Provisional Urban Council. The Administration advised that Government's total commitment in respect of the project would be capped at \$177 million which covered design work and basic infrastructure works. The add-on works of the Park would be contributed by Chi Lin in the form of donations.
- 13. The Subcommittee had no objection to the funding arrangement and the Administration's proposal of entrusting the detailed design, construction and site supervision works of the project to Chi Lin. The Subcommittee had nevertheless reminded the Administration to give careful consideration to the future management of the Park and the need for re-naming the project to reflect its status as a major tourist spot.
- 14. The project was upgraded to Category A of PWP in November 2002.

Kowloon Bay Recreation Ground

15. The Subcommittee noted that the project had been delayed because the design had to be revised to avoid closing a section of Kai Lai Road which fell within the boundary of the project site, and to provide additional spectator capacity. The project, with a revised design, was upgraded to Category A of PWP in April 2002.

Projects which had not received all necessary approvals of the Provisional Municipal Councils

List of 169 projects

16. According to the information provided by the Administration to the Finance Committee in December 1999, there were a total of 169 projects which had not received all necessary approvals of the PMCs and were at various stages of planning before the dissolution of the PMCs. Of the 169 projects, 30 involved environmental hygiene facilities and 139 involved leisure and recreational facilities.

Retrofitting of air-conditioning to existing markets and/or cooked food centres

- 17. The Administration informed the Subcommittee that the former Provisional Urban Council had included 10 projects on retrofitting of air-conditioning to existing markets and/or cooked food centres in the list of 169 projects (paragraph 16 above refers) in 1999. As the list did not include those markets previously managed by the former Provisional Regional Council, the Administration proposed that nine markets/cooked food centres located in the New Territories be included.
- 18. The Subcommittee had strongly urged that all these 19 projects on retrofitting of air-conditioning in existing markets and /or cooked food centres should be taken forward expeditiously in order to improve the hygiene conditions and business environment of these markets. The Subcommittee wrote to the Secretary for the Treasury on 9 April 2001 urging that a special category or "block vote" be created for the ex-PMC projects, including the 19 retro-fitting of air-conditioning projects, so that they could be directly injected into Category C of PWP and accorded funding priority in the annual resource allocation exercise.
- 19. The Subcommittee welcomed the Administration's subsequent agreement in 2001 to earmark funds for these 19 projects. However, the Subcommittee was disappointed that the Administration insisted that a support rate of 85% be adopted for taking forward these projects. The Subcommittee passed a motion at its meeting on 14 November 2002 urging the Administration to lower the support threshold from 85% to 70%.
- 20. The Administration explained that it was necessary to ensure a vast majority support for the proposed projects because the proposed works would cause disruption to the stalls concerned and the lessees had to agree to pay the recurrent air-conditioning charges. Nevertheless, the Administration undertook to try its best by early 2003 to boost up the support rate of markets which have already attained a support rate close to 85%. For those

markets/cooked food centres which had not attained a support rate of 85%, improvement works would be carried out to upgrade the environment and to bring the premises in compliance with the latest statutory requirements.

- 21. After detailed discussion with the Subcommittee and further consultation with the lessees concerned, the Administration informed the Subcommittee in early 2003 that seven markets/cooked food centres had attained a support rate of 85% and the retrofitting of air-conditioning works could proceed. The improvement works for the remaining markets/cooked food centres would also be taken forward by phases. As at 15 May 2003, two retrofitting of air-conditioning projects were upgraded to Category A of PWP. The Administration intended to submit the other projects to the Finance Committee for approval by phases. A table showing the support rates (as at 31 March 2003) for all the 19 markets/cooked food centres is at **Appendix II**. The proposed scope of works to the remaining markets/cooked food centres is at **Appendix III**.
- 22. At the Subcommittee meeting on 22 May 2003, the Administration provided the cost estimates of each of those projects which had yet to be upgraded to Category A of PWP. The Subcommittee noted that in view of the Public Works Subcommittee (PWSC)'s concern about the high costs for retrofitting air-conditioning to the Fa Yuen Street Market and Cooked Food Centre at the meeting on 21 May 2003, the Administration had withdrawn the funding proposal for this project pending further information to be provided to PWSC.
- The Subcommittee shared the concern of PWSC about the high 23. estimated cost (\$79 million) of the Fa Yuen Street Market and Cooked Food Centre project, particularly if the amount of \$30 million for the cooked food centre would only benefit 15 stalls. While the Subcommittee supported the policy direction of improving the business environment and hygiene conditions of markets and cooked food centres, members were inclined to agree that it might not be cost-effective to put in huge resources for the benefit of only a The Subcommittee suggested that the Administration should consider the feasibility of proceeding with the retro-fitting works to the Fa Yuen Street Market first, pending re-consideration by the Administration of the policy in respect of cooked food centres. Some members were of the view that cooked food centres were an outdated business and many operators were rather old and lacked incentive to improve their operation. They suggested that the Administration should consider encouraging existing licensees in cooked food centres to surrender their licences for an enhanced ex-gratia payment. The policy issue in this respect could be further pursued by the relevant Panel.

Projects involving other environmental hygiene facilities

24. Other than the retrofitting of air-conditioning projects, there were 20 projects involving environmental hygiene facilities. The Administration informed the Subcommittee, at its meeting on 7 March 2002, that four of these projects would proceed, seven projects were under review and there was no real need for the other nine projects. As at May 2003, the position of the four projects to proceed was that one project had been completed, one was under construction, one has been upgraded to Category A of PWP, and the other one was under planning. A list showing the latest position of these 20 projects is at **Appendix IV**.

Projects involving leisure and cultural facilities

- 25. There were 139 projects involving leisure and cultural facilities which had not received all the necessary approvals of the former PMCs. At the request of the Subcommittee, the Administration had consulted the 18 DCs in 2001 on the relative priority of these projects. During the consultation, DCs requested priority to 27 projects, 15 of which were subsequently included in the Administration's list of 21 priority projects.
- 26. Given the long list of outstanding projects and the DCs' view that some of their recommended projects had not been included in the Administration's priority list, the Subcommittee had urged the Administration to draw up a five-year rollover programme in 2001 for the implementation of the outstanding projects. The Subcommittee had also urged the Administration to earmark funds for the projects included in the five-year programme so as to obviate the need for the departments concerned to seek funds for individual projects (especially those involving joint users) on an annual basis (paragraph 18 refers). The Subcommittee had reminded the Administration not to renege on its promise that it would maintain the same level of services provided by the former PMCs. Members had also requested the Administration to accord priority to the provision of leisure and recreational facilities in new towns.
- 27. In response to the Subcommittee's request, the Administration informed the Subcommittee in October 2001 that an Accelerated Programme had been drawn up and funds earmarked for 64 projects (estimated capital costs at \$8.7 billion) with construction due to start within the next five years, from 2002-03 to 2006-07. The 64 projects included 59 PMC projects^{Note} and four new projects which were not on the list of 169 projects (paragraph 16 above).

Note Including the Sports Ground, Town Park and Indoor Recreation Centre project in Area 45, Tseung Kwan O, which will be counted as two projects owing to its large scale.

The Accelerated Programme

- 28. As only 15 projects were included in the Accelerated Programme for 2002-03, the Subcommittee had urged the Administration to make further efforts to advance those projects scheduled to start in 2003-04 and beyond.
- 29. The Administration informed the Subcommittee in May 2003 that of these 15 projects scheduled for implementation in 2002-03, the construction works of 13 projects had already commenced or would start shortly. One of the remaining projects (Sheung Lok Street Rest Garden) would be carried out as a minor works item due to reduction in scope, while the other one (Recreation Ground in Area 33, Tai Po) would be slightly deferred.
- 30. As regards the remaining projects, the Administration informed the Subcommittee that it was critically reviewing their priorities, delivery mode and implementation schedule, taking into account the views of the DCs concerned.
- 31. According to the information provided by the Administration in May 2003, a priority list of 26 projects, including 19 projects under the Accelerated Programme, had been drawn up and provisions earmarked for their implementation in the financial year 2003-04. As at 15 May 2003, nine of the 26 priority projects have been upgraded to Category A of PWP. A list of the 26 priority projects is in **Appendix V**.
- 32. As for the other 45 projects in the Accelerated Programme, the position as at 15 May 2003 was that four have been upgraded to Category A, while another four were being carried out as minor works items. Three open space projects were proposed to be deleted due to delay in site formation and reclamation programme. Two other projects had been selected as pilot projects for implementation through the Private Sector Finance approach.
- 33. The Administration advised that it would constantly review the remaining 32 projects in the Accelerated Programme having regard to the changing economic situation and the long-term financial capability in commissioning the new facilities. A list showing the latest position of the 64 projects in the Accelerated Programme is in **Appendix VI**.

Private sector involvement

34. The Administration informed the Subcommittee on 22 May 2003 that in order to speed up the delivery of the projects involving leisure and cultural facilities, it was examining the possibility of involving the private sector in implementing some of the priority projects. The Subcommittee noted that nine projects (seven in the Accelerated Programme and two new projects) from the 26 priority projects would be selected for private sector involvement under

the Design-Build approach or the Design-Build-Operate approach. These projects included the provision of indoor heated swimming pools in Lai Chi Kok, Yuen Long and Shai Tin, indoor recreation center-cum library in Tung Chung, district open space and sports ground in North District, Tsuen Wan and Tung Chung. In addition, two projects, namely, a leisure and cultural centre in Kwun Tong and a town park with an ice sport centre in Tseung Kwan O would be selected as pilot scheme for the Private Sector Finance approach.

35. The Subcommittee noted that the proposal had been discussed by the Panel on Home Affairs at its meeting on 11 April 2003. The Subcommittee welcomed the option of inviting private sector participation as a means to expedite the implementation of these projects and to reduce the operating costs of the Government. The Subcommittee suggested that the Administration should include more projects under such schemes as far as practicable.

Projects not included in the Accelerated Programme

- 36. As regards the remaining projects not included in the Accelerated Programme, the Home Affairs Bureau informed the Subcommittee in July 2002 (Paper No. CB(2) 2455/01-02(03)) that eight projects could be implemented as minor works items, and there was no need for eight other projects which would be deleted from the PWP. For the nine projects which the DCs had requested early implementation subject to budgetary constraints, the Administration would carefully consider them in the context of the established procedures for PWP projects. For the remaining 50 projects, the Bureau advised that it would review in consultation with respective DCs on a continuous basis to identify justified projects where there were changes in circumstances which render them suitable for development.
- 37. A summary of the progress made in respect of the ex-PMC projects is in **Appendix VII**.
- 38. A list of the relevant papers and documents referred to is attached in **Appendix VIII**.

Policy issues raised by the Subcommittee

- 39. During discussion with the Administration on the criteria for according priority to the outstanding projects and ways to expedite the delivery of these projects, members of the Subcommittee had raised the following policy issues -
 - (a) the policy and planning standards for the provision of leisure and cultural facilities in districts and new towns:

- (b) the policy and design of public markets should be reviewed to see whether they can still meet market demands and community expectations;
- (c) the viability of certain public markets and cooked food centres should be critically reviewed to see if any of them should be closed; and
- (d) the possibility of inviting private participation in the provision and management of district recreational and cultural facilities.
- 40. Members considered that there should be a suitable forum for these policy issues to be further pursued. Some of these issues had already been taken up by the relevant Panels.

Way forward

- 41. At the Subcommittee meeting on 22 May 2003, members considered the way forward for the Subcommittee. Their views are summarised below -
 - (a) the Subcommittee had completed its mission of urging the Administration to implement the outstanding projects of the former PMCs. Not only had the 12 projects with funding set aside had been upgraded to Category A of PWP (paragraphs 4 and 5 above), a five-year roll-over programme had also been formulated after consultation with the DCs, with funding earmarked, for the implementation of projects involving leisure and cultural facilities (paragraphs 27 to 36 above). The Administration had also agreed to upgrade the environment of 19 existing markets and/or cooked food centres (paragraph 21 above);
 - (b) given the change in circumstances, the Administration had concluded, after consultation with the relevant DCs, that there was no real need for some projects on the original list of 169 projects, and these projects would not proceed (paragraphs 24 and 36 above). It was also impracticable to demand implementation of all outstanding projects given the changing needs and the current economic situation;
 - (c) it was beyond the scope of work of the Subcommittee to pursue policy issues which were under the purview of the relevant LegCo Panels. On the other hand, it would be difficult for the Subcommittee to discuss the overall priority of ex-PMC projects without discussing the new policies being developed by the

relevant bureuex. For example, the Private Sector Involvement Programme had been launched by the Home Affairs Bureau recently for the implementation of some ex-PMC projects (paragraphs 34 and 35 above); and

- (d) there had been overlapping discussion on individual projects by the Subcommittee, the relevant Panel(s) and PWSC. Members who were members of both the Subcommittee and PWSC faced a dilemma recently when PWSC expressed reservation at its meeting on 21 May 2003 about the funding application of the retro-fitting of air-conditioning to Fa Yuen Street Market and Cooked Food Centre (paragraphs 22 and 23 above).
- 42. The Subcommittee is of the view that the Subcommittee should conclude its work and report to the House Committee in June 2003. The Subcommittee recommended that the relevant Panels should continue to follow up the outstanding projects and receive periodic progress reports by the Administration.

Advice sought

43. Members are invited to note the recommendation of the Subcommittee in paragraph 42 above.
