Legal Service Division Report on Import and Export (Facilitation) Bill 2003

I. SUMMARY

1. Objects of the Bill

This Bill seeks to provide for the relaxation of import, export and transportation control on certain articles.

2. Comments

- (a) The Carriage Licence for air conditioners and refrigerators and the export certification requirement for television sets, video cassette recorders and players and poultry carcasses and products will be removed.
- (b) The Import Licence and Export Licence for left hand drive vehicles and outboard engines exceeding 111.9 kilowatts will be removed while their Carriage Licences will be retained.
- (c) The relevant permits for marine fish as transhipment cargoes and Notification of Exports will be removed.
- (d) A combined Import and Export Licence will be introduced for transhipment of ozone depleting substances.
- (e) Instead of licensing controls, a pre-shipment notification system will be introduced for optical disc mastering and replication equipment, and radiocommunications transmitting apparatus.
- 3. Public Consultation

Relevant trades have been consulted. They all welcome the relaxation measures.

4. Consultation with LegCo Panels

The policy aspects of the Bill were discussed at the meeting of the Panel on Commerce and Industry on 14 April 2003.

5. Conclusion

Subject to Members' views on the policy aspects of this Bill, Members may wish to defer a decision on the Bill pending our submission of a further report on its technical aspects.

II. REPORT

Objects of the Bill

To amend three Ordinances and seven regulations so as to remove or relax the import, export and transportation control on television sets, video cassette recorders, video cassette players, air conditioners, refrigerators, poultry carcasses and poultry products, left hand drive vehicles, outboard engines exceeding 111.9 kilowatts, marine fish, ozone depleting substances, optical disc mastering and replication equipment and radiocommunications transmitting apparatus.

Comments

- 4. According to the Administration, there are 31 categories of articles currently subject to licensing control on their import, export and transhipment, and in some cases, their storage or movement in Hong Kong. The controls are imposed mainly for the purposes of fulfilling the international obligations of Hong Kong, public health or safety, anti-smuggling, or protection of public revenue.
- 5. To facilitate trade, the Administration has reviewed the licensing control and proposed to relax licensing control on the following categories of articles. Details of the relaxation are listed as follows-

6. According to the Administration, the relaxation measures in respect of strategic commodities, pesticides, radioactive substances and irradiating apparatus and firearms and ammunition will be pursued separately.

Public Consultation

7. The Trade and Industry Advisory Board, the Small and Medium Enterprises Committee, the Business Advisory Group, the Advisory Council of the Environment as well as over 50 relevant trading and transport associations and companies have been consulted. They all welcome the relaxation measures.

Consultation with LegCo Panel

8. The Panel on Commerce and Industry was consulted on the proposal at the meeting held on 14 April 2003. Members of the Panel were generally in support of the Administration's proposal. Some members did not support relaxing the licensing control on strategic commodities and firearms and ammunition, which are not covered by the Bill.

Conclusion

9. Subject to Members' views on the policy aspects of this Bill, Members may wish to defer a decision on the Bill pending our submission of a further report on its technical aspects.
