2. The Subcommittee deliberated the draft Ocean Park Bylaw provided by the Administration (index of proceedings attached at **Annex**).

3. Mr Henry WU declared interest as Director of the Board of the Ocean Park Corporation.

Amendments to the draft Bylaw

4. The Administration and the Ocean Park Corporation undertook to make the following amendments to the draft Bylaw -

(a) revising the Chinese text of section 5(3)(n) to make it clear that the "reasonable excuse" clause covered the acts of putting one's feet on and lying down on a seat or bench;

(b) deleting the word "normal" in section 5(7)(m) and section 16(5)(h); and

(c) deleting the phrase "for a full day" from section 19(2)(b).

5. Members raised no other queries on the draft Bylaw.

Way forward

6. Members agreed that the Administration and the Ocean Park Corporation should incorporate the amendments set out in paragraph 4 above and provide the draft Ocean Park Bylaw as amended for circulation to members. If members raised no queries on the draft Bylaw as amended, the Subcommittee would report to the House Committee that it did not object to the gazettal of the draft Bylaw.
