Having considered the trade's concerns and the consequences of repealing or not repealing the Public Revenue Protection (Revenue) Order 2003 (the Order), the Subcommittee considered it inappropriate to repeal the Order. The Subcommittee recommended that a Bills Committee should be formed to scrutinize the Revenue Bill 2003 as soon as possible.
