I. Confirmation of minutes

The minutes of the meeting held on 8 January 2003 were confirmed. **1.**

II. Meeting with the Administration

(LC Paper Nos. CB(2)1324/02-03(01) and LS72/02-03)

- 2. <u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).
- 3. The Administration was requested to -
 - (a) explain the implications, if any, of the approval of the draft Order on mutual legal assistance arrangements between Hong Kong and overseas jurisdictions on extradition of offenders;
 - (b) provide information on a case in which a Filipino was extradited to the United States (US) in mid 2000 for trial of an offence of spreading computer viruses to computers in the US, and the relevant legislation in the US which provided the legal basis for the US courts to exercise jurisdiction over the offence in question;
 - (c) explain the legislative intent of section 161 of the Crimes Ordinance, the elements of the offence under the section, and the justifications for making the offence a criminal offence. Some members had expressed concern that the scope of the offence was too wide;

Action

- (d) respond to the view that the principal Ordinances concerned (i.e. the Telecommunications Ordinance and the Crimes Ordinance) should be amended to set out the extra-territorial scope of the three specific computer offences;
- (e) respond to the view that consideration of the draft Order should be deferred until completion of the scrutiny of the National Security (Legislative Provisions) Bill (the Bill) because clause 11 of the Bill was related to two of the computer offences specified in the draft Order, i.e. the offences under section 27A of the Telecommunications Ordinance and section 161 of the Crimes Ordinance. According to some members, approval of the draft Order ahead of passage of the Bill would pre-empt deliberations on the extra-territorial application of the relevant offences under the Bill.
