#### I. Election of Chairman

Mr James TO was elected Chairman of the Subcommittee.

## II. Meeting with the Administration

[LC Paper Nos. CB(2) 1226 & 1265/02-03]

- 2. The Subcommittee deliberated (Index of proceedings attached at **Annex**).
- 3. The Administration took members through the Mutual Legal Assistance in Criminal Matters (Ireland) Order and, in particular the comparison of the various Articles in the Agreement itself with the Articles in the model agreement [LC Paper No. CB(2) 1226/02-03(01)].
- 4. In scrutinising the Mutual Legal Assistance in Criminal Matters (Ireland) Order, members raised questions on certain paragraphs in the Order, particularly on their consistency with the Mutual Legal Assistance in Criminal Matters Ordinance.
- 5. <u>Members</u> also requested the Administration to provide additional information to supplement its explanation given at the meeting to address the concerns raised by members as follows -

## Article 8

(a) whether the Government of Hong Kong Special Administrative Region could contest an application for the making of a court order for release of information provided by Ireland on the basis that to do so would breach the confidentiality requirement in this Article;

#### Article 9(5)

(b) the rationale for the second sentence of Article 9(5) which would allow a witness who was required to give evidence pursuant to a request for assistance to assert a claim of immunity or privilege under the law of the Requesting Party, and yet at the same time to require that the evidence be given;

- (c) the procedures for taking of evidence where claims of immunity pursuant to the second sentence in Article 9(5) were made;
- (d) the different scenarios for taking of evidence under Article 9(5), i.e. when a witness asserted a claim of immunity or privilege under the law of Requesting Party, which was not permitted under the law of the Requested Party, and vice versa; and
- (e) regarding the second sentence in Article 9(5), as the witness was required to give evidence first even though he could assert a claim of immunity or privilege under the law of the Requesting party, the reasons why the Administration considered it proper for a Requesting Party to make use of Hong Kong as a conduit to ask for information which it otherwise would not have been able to obtain within its own jurisdiction.
- 6. The Chairman also requested the Secretariat to trace the background on the deliberations of the then Bills Committee on the Mutual Legal Assistance in Criminal Matters Bill on section 10(7) and (9) of the Ordinance.

### **III.** Date of next meeting

- 7. <u>The Chairman</u> said that the Subcommittee would study the Mutual Legal Assistance in Criminal Matters (Netherlands) Order at the next meeting. The Secretariat would inform members the date of next meeting in due course.
- 8. There being no other business, the meeting ended at 10:20 am.
