I. Election of Chairman

Mr Kenneth TING was elected Chairman of the Subcommittee.

2. <u>The Chairman</u> said that Mr Bernard CHAN had requested to join the Subcommittee after the deadline for signification of membership. <u>Members</u> acceded to Mr CHAN's request under Rule 23(b) of the House Rules.

II. Meeting with the Administration

[LC Paper Nos. CB(2) 1460 & 1494/02-03]

- 3. The Subcommittee deliberated (Index of proceedings attached at **Annex**).
- 4. <u>The Administration</u> briefed members on the two proposed resolutions on revising the levels of medical expenses payable under the Employees' Compensation Ordinance (ECO) and the Pneumoconiosis (Compensation) Ordinance (PCO) to keep in line with the new fee structure of the public health care services which would come into effect on 1 April 2003.
- 5. While members were in support of the proposal, some of them expressed concern about the implications of the proposal on the premium level of employees' compensation insurance and the transitional arrangement for the payment of the difference between the existing rates and the revised rates of medical expenses, if the proposed resolutions could not come into operation on 1 April 2003.
- 6. Having considered the supplementary information provided by the Administration in its paper (LC Paper No. CB(2) 1494/02-03(01)) and at the meeting, members expressed support for the two proposed resolutions. To minimise the impact on injured employees and pneumoconiotics, members also supported the Administration's proposal of -
 - (a) its giving fresh notice to move the two proposed resolutions at the earliest Council meeting after 1 April 2003 (i.e. the Council meeting commencing on 2 April 2003); and

(b) its seeking the leave of the President to dispense with the notice requirement for moving motions under Rule 29(1) of the Rules of Procedure.

- 7. The Chairman said that the Subcommittee would report its deliberations and recommendations to the House Committee at the meeting on 21 March 2003.
