I Election of Chairman

Mr IP Kwok-him was elected Chairman of the Subcommittee.

II. Meeting with the Administration

[LC Paper No. CB(2) 2358/02-03(01)]

- 2. The Subcommittee deliberated (Index of proceedings attached at **Annex**).
- 3. Mr James TO expressed concern about the preparatory work for the launching of the Smart Identity Card System. He explained that as the territory-wide identity card replacement exercise was mandatory, it was necessary to ascertain that the system and all ancillary measures were ready before implementation. Mr TO also considered it necessary to study the report of the third Privacy Impact Assessment before the launching of the system. Some other members, however, expressed reservation that the report was of direct relevance to the examination of the two Orders. They agreed, nevertheless, that the Administration should provide the report to the Panel on Security once the report was available.
- 4. In response to Mr James TO, the Administration advised that the technical problems earlier identified in the system had been resolved. The Immigration Department had conducted a series of tests and trial runs, and was confident that the new system would commence live run as scheduled on 23 June 2003. The Administration also informed the Subcommittee that a visit was being arranged for members of the Panel on Security and other interested Members to view a demonstration on the Smart Identity Card System in the real working environment in the morning of 17 June 2003.

- 5. In response to further enquiries from Mr James TO and Mr LAU Kong-wah, the Administration said that it would -
 - (a) provide relevant training to law enforcement officers not specified in the Registration of Persons (Application for New Identity Cards) Order, e.g. members of Customs and Excise Department and Independent Commission Against Corruption;
 - (b) launch local and overseas publicity programmes in a timely manner in tandem with the replacement exercise; and
 - (c) provide a report of the third Privacy Impact Assessment to the Panel on Security at an early date.
- 6. Mr James TO also enquired about the reasons for including members of the Immigration Service, police officers and labour inspectors, but not members of Customs and Excise Department and Independent Commission Against Corruption, in the first phase of the replacement exercise. The Administration advised that members of the Immigration Service, police officers and labour inspectors were required to enforce sections 17C and 17L of the Immigration Ordinance. There was a practical need for them to familiarise with the features of the new identity cards.
- 7. <u>Mr James TO</u> requested that the Administration should provide the report of the third Privacy Impact Assessment to the Panel preferrably before 2 July 2003 (i.e. the deadline for giving notice of amendments to the Orders, if the scrutiny period of the Orders is extended to 9 July 2003).
- 8. Mr James TO also enquiried whether a Hong Kong resident living abroad was required to apply for the new identity card within the specified time. The Administration advised that under section 7B(4) of the Registration of Persons Ordinance, a person who was absent from Hong Kong at the time when he was required by an order to apply for an identity card would not be regarded as failing to comply with the order provided that he applied for an identity card within 30 days of his return to Hong Kong. The person would be liable to an offence for not applying for an identity card during his return to Hong Kong only if his period of stay in Hong Kong exceeded 30 days. For example, if the resident living overseas stayed in Hong Kong for only 7 days, he would not be liable to an offence for not applying for a new identity card under the Registration of Persons Ordinance.
- 9. The Subcommittee completed the scrutiny of the two Orders. The Administration was requested to consider Mr James TO's request for providing the report of the third Privacy Impact Assessment before 2 July 2003.

III. Any other business

- 10. To allow time for the Administration to respond to the concerns raised by members at the meeting and to enable the Subcommittee to provide a report to the House Committee, the Chairman said that he would give notice to move a motion at the Council meeting on 18 June 2003 to extend the scrutiny period of the Orders to 9 July 2003. Members agreed.
- 11. <u>The Chairman</u> said that no further meeting would be held unless members had further comments on the two Orders or the information to be provided by the Administration. <u>Members</u> agreed.
- 12. The meeting ended at 5:55 pm.
