Legislative Council Panel on Education Review of the funding of sub-degree programmes

Introduction

The Government has reviewed its policy on the funding of sub-degree programmes. This paper outlines the development of this review.

Background

2. The University Grants Committee (UGC) conducted a comprehensive review of the higher education sector in Hong Kong and submitted its recommendations to the Government in 2002, following a four-month period of public consultation.

3. One of the main recommendations accepted by the Government is that sub-degree programmes should in general be self-financing, but exceptions should be made for the following courses -

- (a) courses that require high start up and maintenance costs or access to expensive laboratories/equipment;
- (b) courses that meet specific manpower needs; and
- (c) courses that can be regarded as endangered species (i.e. those that lack market appeal to the provider and the average student, such as pure arts or science).

4. We consider that with an expanding post secondary sector, there is a need to free up resources so that more students may benefit from public subsidy in one form or another. The above measure will help achieve a more equitable distribution of resources. The Government also undertakes that most of the savings achieved would be used to benefit students in the sub-degree sector, for example, by enhancing their financial assistance.

Latest development

5. To follow up, a specialist group was set up by the UGC in early 2003 to review the existing UGC-funded sub-degree programmes offered by City University of Hong Kong (CityU) and the Hong Kong Polytechnic University. The specialist group, comprising UGC members, local academics, and industry representatives, was tasked to examine the institutions' proposals, and to consider submissions received from professional groups and interested parties.

6. Apart from the three exemption criteria set out in paragraph 3 above, the specialist group also worked to the following guiding principles:

- (a) Programmes with comparable alternatives in the market, which include programmes offered by the continuing education arms or community colleges of UGC institutions, should go first.
- (b) Programmes proposed for conversion by the concerned institutions themselves should go first.
- (c) Implementation should be gradual, as far as possible.
- (d) Same treatment for similar programmes offered across institutions.
- (e) Protection of students in the pipeline.

7. The UGC, based on the recommendations of the specialist group, finalised the plan for withdrawal of subvention and informed the affected institutions of the UGC's decision in May 2003.

8. The plan in respect of CityU is at <u>Annex</u>. By the end of the 2005/06 to 2007/08 triennium, the UGC will be funding about 30% of CityU's existing sub-degree programmes, which take up around 25% of CityU's existing student numbers at sub-degree level.
