

TERMS OF REFERENCE AND MEMBERSHIP OF TEAM CLEAN

The Chief Executive announced the setting up of Team Clean on 5 May 2003, in the wake of the SARS outbreak, to develop and take forward proposals for entrenching a high level of public and environmental hygiene in Hong Kong.

Mission

Team Clean's mission is to establish and promote a sustainable, cross-sectoral approach to improve environmental hygiene in Hong Kong.

Terms of Reference

The terms of reference of Team Clean are –

- to develop a coherent system and strategy for integrating and augmenting environmental hygiene improvement initiatives across all concerned bureaux and departments in Government. The system and strategy should be capable of sustaining a high level of cleanliness throughout the territory;
- to determine the relative priorities of areas targeted for improvement action, marshalling as much as possible wider community support, particularly that of the District Councils and non-governmental organizations to help tackle these areas;

- to draw up within a period of three weeks a work plan of short-term measures to be taken and to steer and direct the implementation of these measures; and
- to establish within a period of three months a sustainable system and a time frame for implementing the medium- and long-term initiatives.
