REGISTRATION OF PERSONS (APPLICATION FOR NEW IDENTITY CARDS)(REPEAL) ORDER 2003

INTRODUCTION

The Registration of Persons (Application for New Identity Cards) Order has been issued under section 7B(1) of the Registration of Persons (ROP) Ordinance, Cap.177 to direct certain categories of persons to apply for new identity cards within a specified period at smart identity card centres. The Registration of Persons (Application for New Identity Cards) (Repeal) Order 2003 has also been made to repeal orders issued for the last territory-wide replacement exercise.

BACKGROUND

2. The Commissioner of Registration has appointed 23 June 2003 as the specified date on which the Smart Identity Card System (SMARTICS) starts operation. From this date onwards, applicants for new identity cards¹ or applicants for replacement of lost, destroyed, damaged or defaced identity cards will be issued new identity cards embodying chips.

3. Holders of Hong Kong identity cards (some 6.9 million) will be invited to come forward by age groups to have their old identity cards applied or issued before 23 June 2003 replaced. Such a territory-wide identity card replacement exercise will commence on 18 August 2003, two months after the SMARTICS starts operation. Similar to previous

exercises, the current exercise will last for about four years. Since the Automated Passenger Clearance System and the Automated Vehicle Clearance System to be introduced at our control points by phases at end 2004 will exploit the smart card technology, frequent travellers, i.e. those aged 34 to 55, will be invited to apply for new identity cards during the first four cycles of the exercise (from September 2003 to June 2005). Other age groups will be invited to particiapte in the latter four cycles. Separately, we will make arrangement for all cross-boundary drivers to apply for the new identity cards before end 2004 so that they may benefit from the Automated Vehicle Clearance System nearer the time. Details of the full replacement exercise are at <u>Annex A</u>.

4. The Secretary for Security has issued the Registration of Persons (Application for New Identity Cards) Order ("the ROP Order") (Annex B) under section 7B(1) of the ROP Ordinance, Cap. 177 announcing details of the first cycle of the execrise. The ROP Order has directed holders of identity cards born between 1964 to 1969, members of the Immigration Service, police officers and labour inspectors to apply for identity cards within the specified periods. There is a practical need for the above law enforcement officers to familiarize with the features of the new identity cards as early as possible so as to facilitate them to fight crimes relating to illegal immigration and illegal employment.

5. The ROP Order has also provided the Chief Executive, members of the Executive Council and the Legislative Council and Principal Officials with an option to apply for the new identity cards at an early stage as the important public office they hold put them in a unique position to promote the use of information technology in the community and Hong Kong as a leading digital city in the region.

6. The Secretary for Security has also made the Registration of Persons (Application for New Identity Cards) (Repeal) Order 2003 ("the Repeal Order") (<u>Annex C</u>) to repeal orders issued for the last territory-wide replacement exercise held from July 1987 to October 1991, which have already lapsed.

THE ORDERS

7. Section 1 of the ROP Order provides for its commencement date and Section 2 the interpretation of terms. Section 3 specifies the application arrangements for certain categories of persons. Schedule 1 specifies the names and locations of the smart identity card centres while Schedule 2 specifies the application periods for holders of identity cards born between 1964 and 1969. The Repeal Order repeals orders that were issued for the last replacement exercise.

PUBLIC CONSULTATION

9. Since the launch of the HKSAR Identity Card Project, the public and members of the Legislative Council have been informed of our intention to conduct the replacement exercise in mid-2003.

IMPLICATIONS OF THE PROPOSAL

10. The Orders are in conformity with the Basic Law, including the provisions concerning human rights.

BINDING EFFECT OF THE LEGISLATION

11. The ROP Order will not affect the current binding effect of the ROP Ordinance (Cap. 177) and the ROP Regulations (Cap. 177, sub. leg.) made thereunder.

PUBLICITY

12. Immigration Department will hold a press conference on 16 May 2003 to announce details of the replacement exercise.

REGISTRATION OF PERSONS (APPLICATION FOR NEW IDENTITY CARDS) ORDER

(Made under section 7B(1) of the Registration of Persons Ordinance (Cap. 177))

1. Commencement

This Order shall come into operation on 10 July 2003.

2. Interpretation

In this Order, unless the context otherwise requires -

- "smart identity card centre" (智能身分證中心) means a smart identity card centre specified in Schedule 1;
- "valid identity card to be replaced" (有待取代的有效身分證) means a valid identity card issued before 23 June 2003 or issued on or after that date on an application made before that date.

3. Applications for new identity cards

- (1) This section applies to -
 - (a) the Chief Executive;
 - (b) any member of the Executive Council;
 - (c) any member of the Legislative Council;
 - (d) any principal official appointed pursuant to a nomination under Article 48(5) of the Basic Law;
 - (e) any member of the Immigration Service;
 - (f) any police officer; and
 - (g) any public officer at the rank of Chief Labour Inspector, Senior Labour Inspector, Labour Inspector I or Labour Inspector II.

(2) A person to whom this section applies who holds a valid identity card to be replaced shall apply for a new identity card at a smart identity card centre –

- (a) within the period from 18 August 2003 to 15 November 2003; or
- (b) in the case of a person referred to in subsection (1)(a), (b),(c) or (d), within the period directed from time to time under subsection (3) which is applicable to him.

(3) Subject to subsection (2), a person who holds a valid identity card to be replaced bearing a year of birth specified in column 1 of Schedule 2 shall apply for a new identity card within the period specified opposite thereto in column 2 of that Schedule at a smart identity card centre.
