1. Commencement

This Notice shall come into operation on 1 July 2003.

- 2. Change of titles
 - (1) (a) The titles of--
 - (i) the Government Land Transport Agency;
 - (ii) the Government Supplies Department; and
 - (iii) the Printing Department,

are declared to be changed to the Government Logistics Department.

- (b) The title of the Government Printer, where it denotes a government department, is declared to be changed to the Government Logistics Department.
 - (2) The titles of--
- (a) the Government Land Transport Administrator;
- (b) the Director of Government Supplies; and
- (c) the Government Printer, where it denotes a public officer, are declared to be changed to the Director of Government Logistics.
- 3. Amendment of references to titles
- (1) The enactments specified in column 2 of Schedule 1 are amended in the provisions specified opposite thereto in column 3 of that Schedule by substituting "Government Logistics Department" for the titles specified opposite thereto in column 4 of that Schedule.
- (2) The enactments specified in column 2 of Schedule 2 are amended in the provisions specified opposite thereto in column 3 of that Schedule by substituting "Director of Government Logistics" for the titles specified opposite thereto in column 4 of that Schedule.
- 4. Substitution of titles in other instruments, contracts or legal proceedings

The titles specified in column 3 of Schedule 3 are substituted for those specified opposite thereto in column 2 of that Schedule wherever occurring in any instruments,

contracts or legal proceedings made or commenced before 1 July 2003.
